Township 28 North, Range 11 West, NMPM, San Juan County, New Mexico

The above-named company is hereby authorized to commingle Basin-Fruitland Coal (Gas – 71629) and Basin-Dakota (Prorated Gas – 71599) Gas Pool production from the above mentioned lease. It is our understanding that the purpose of this commingling is to utilize produced gas from the E. H. Pipkin Well No. 36-2 to lift liquids in the E. H. Pipkin No. 5E, and that production from each well will be determined as follows:

E. H. Pipkin No. 5E production = Meter No. 35701 (E. H. Pipkin No. 5E) – Meter No. 3 (Dry flow meter from E. H. Pipkin No. 36-2 to E. H. Pipkin No. 5E)

E. H. Pipkin No. 36-2 production = Meter No. 29013 (E. H. Pipkin No. 36-2) + Meter No. 3 (Dry flow meter from E. H. Pipkin No. 36-2 to E. H. Pipkin No. 5E)


Oil production will not be commingled. Fuel gas usage will be allocated equally between the wells.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled natural gas production shall be delivered to a gas sales meter located in the NE/4 of Section 36, Township 28 North, Range 11 West, NMPM, San Juan County, New Mexico.

FURTHER: The operator shall notify the Aztec District Office of the Division upon implementation of commingling operations.
