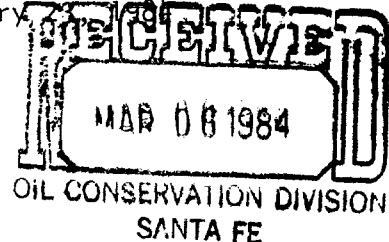

Gentlemen:

ENSTAR Petroleum, Inc., respectfully requests an exception to Rule 309-A to permit production from our McClure "E" Lease to be transported prior to measurement to our McClure "A" Lease.

We plan to use an existing surplus tank battery that was at one time utilized by the McClure "A" No.1. A separate heater treater will be installed. By using these tanks in their existing location, we will not have to bear the expense of moving them and will be able to limit our use of the surface lands. Also, a gas sales line and a connection to a saltwater disposal system are convenient to the location. The total installation cost for our surface facilities will be reduced considerably.

No commingling of production from the two leases will result. There will be no intercommunication of the handling, separating, treating, or storage facilities. The attached plat shows the leases in question, the wells on the leases, and the producing formations.

A certified letter has been sent to all concerned working interest owners notifying them of our intent to transport production between the leases in question prior to measurement. State or Federal lands are not involved.

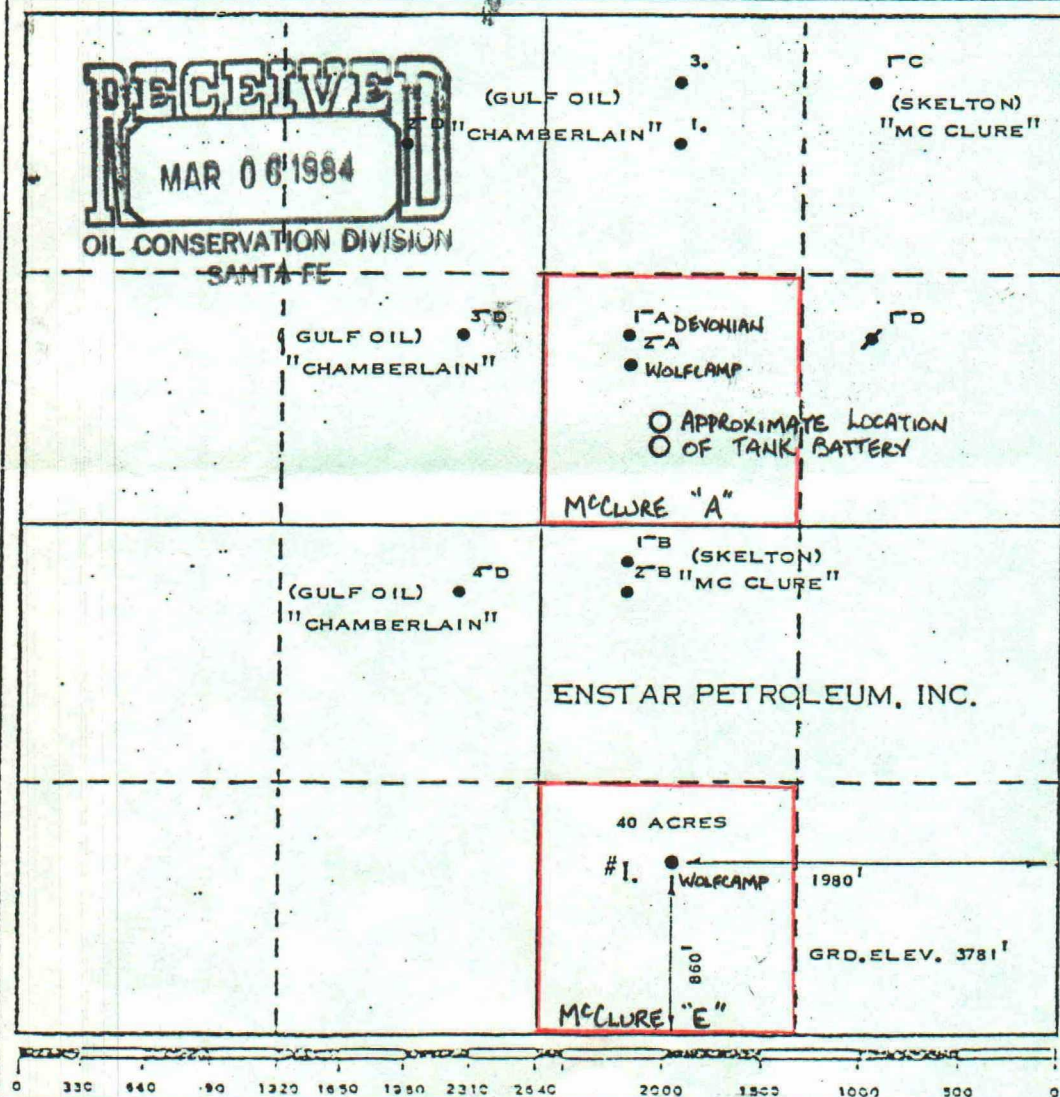
