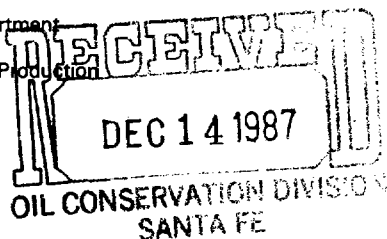

Dear Mr. LeMay:

Conoco Inc. respectfully requests an amendment to Commingling Order CTB-332, dated November 5, 1987. We wish to include the production from the Dagger Draw No. 1, 660' FNL and 660' FWL, Section 30, T-19S, R-25E. This well also produces from the North Dagger Draw Upper Penn pool.

The quality of this crude is identical and commingling will not reduce the commercial value. Also, oil production will be metered at each well using positive displacement temperature compensated metering equipment and production will be allocated back to each lease based on meter volumes.

In addition Conoco requests approval for off-lease storage for the following wells which will be producing into this commingled battery.

Dagger Draw No. 1	D-30-19S-25E
Dagger Draw No. 5	B-30-19S-25E
Dagger Draw No. 8	J-30-19S-25E

This battery will be located at the Dagger Draw No. 4, Unit L, Section 19, T-19S, R-25E.
