Gentlemen:

Reference is made to your application dated March 20, 1974, for administrative approval of an exception to the provisions of Commission Rule 303-A to permit the commingling of condensate only from several wells in Rio Arriba and San Juan Counties, New Mexico, allocating the condensate production to each zone on the lease by means of periodic gas-liquid ratio tests. It is our understanding that the ownership in each of the proposed commingling installations is identical throughout, including working interest, royalty interest, and overriding royalty interest.

Pursuant to the authority granted me by Commission Rule 303-B, Amoco Production Company is hereby authorized to commingle the condensate production from each of the following pairs of wells, allocating production by means of annual gas-liquid ratio tests:
