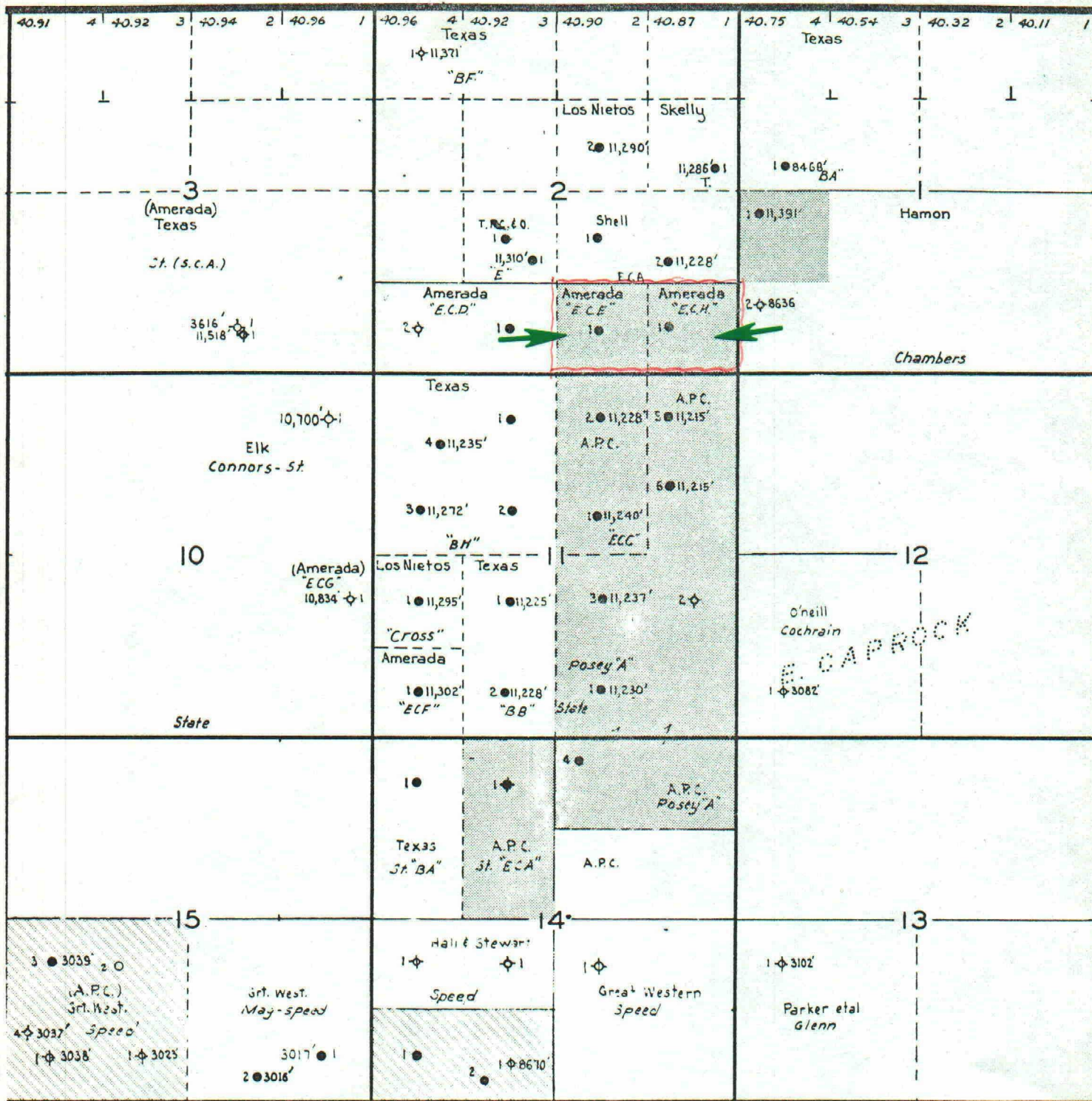

Dear Sir:

Amerada Hess Corporation request permission to consolidate the batteries and commingle the production of the State EC "H" and State EC "E" leases.

The leases are located in the East Caprock Field, Section 2, T-12-S, R-32-E, Lea County, New Mexico. They are one well leases producing from the Devonian formation. The wells are Marginal producers and the production will be allocated on the basis of well tests.

The heater-treater on the State EC "H" Lease is in need of repairs. Commingling of the production will lower the maintenance and operating costs which will lower the economic limit and therefore extend the producing life of the wells.
