Dear Sir/Madam:


We received approval on February 19, 2002, to convert the Louise Yates State #1 to a water disposal well. Please see the attached copy of the Order. Since receiving the approval, we have not disposed of water in the well.

Following that approval, we drilled the Louise Yates State #4, which is approximately 2640 feet north of the #1, and located on the same Lease - #VA-2401. Unfortunately, we have recently determined that the #4 well will not be an economic oil producer. We also determined that because of the better porosity in the #4 than in the #1, the #4 would make a much better disposal well than would the #1. Today we are submitting to your office an application to convert the #4 to a water disposal well. Also today, I talked with Mr. Jones in your office and he suggested that we request an extension of the SWD-830 (related to the #1) in case there should be any problems in establishing the #4 as a disposal well.

Thus, we request that we be granted a 6-month extension of the Administrative Order SWD-830. If the #4 is approved as a disposal well, we plan to plug the #1

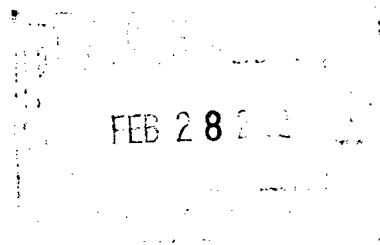




