REQUEST FOR AMENDMENT TO ADMINISTRATIVE COMMINGLING ORDER CTB 240 AND CANCELLATION OF ORDER CTB 246 NORTH VACUUM ABO POOL LEA COUNTY, NEW MEXICO

Gentlemen:

Mobil Oil Corporation respectfully requests that Administrative Order CTB 240, as amended November 10, 1972, be further amended so as to permit the commingling of production from the North Vacuum Abo Pool from the State "TT" Com. Lease located in the N/2 SE/4 Section 7, T17S, R35E, in addition to the presently commingled Abo production from the State "A" Com. Lease in the E/2 SW/4 of said Section 7; the State "JJ" Lease in the W/2 SW/4 of Section 7; and the State "MM" Lease in the S/2 SE/4 of Section 7. The proposed commingling would be in the existing State "A" Com. tank battery located in the SE/4 SN/4 of said Section 7.

The Abo production from the State "TT" Com. Lease is presently commingled with the Abo production from the State "NN" Lease by authority granted January 14, 1974 in Administrative Order CTB 246. We now find it necessary to abandon the Abo production on the State "NN" Lease, and Abo production facilities will no longer be available at that location. If this application is approved, Order CTB 246 could be cancelled concurrent with the connection of the State "TT" Com. Lease to the State "A" Com. tank battery.

All of the leases of this application have common royalty and over-riding royalty ownership; however, the State "TT" Com. Lease does have diverse working interest ownership. We have secured a Letter of Consent to the proposed commingling from the working interest owner of the State "TT" Com. Lease and are attaching it to this application. All of the Abo production

of this application is of a marginal nature. Due to the diverse working interest ownership, we propose to produce the State "TT" Com. Lease through metering facilities and allocate the production to the lease by periodic metered results. We request that the remaining commingled production at the State "A" Com. tank battery continue to be allocated to each well by quarterly well tests, as presently provided for in Order CTB 249.



STATE"A"COM, STATE"JJ", STATE"MM"


NORTH VACUUM ABO
