John H. Hendrix Corporation respectfully requests an exception to Rule 303A to permit the commingling in common facilities of our commonly owned production from the Wantz-Fusselman and Penrose Skelly Grayburg Pool. Due to marginal status of the wells it is requested that allocation between pools be based on quarterly well tests.

In support of this application please find the following:

- 1.) Table I showing gravity, producing rates and classification of oil.
- 2.) Schematic diagram of the proposed installation.
- 3.) A plat showing the location of all wells on the lease and pool from which each is producing.
- 4.) The actual commercial value of the commingled production will not be less than the sum of the values of the production if sold separately.
- 5.) Neither well is producing top allowable.



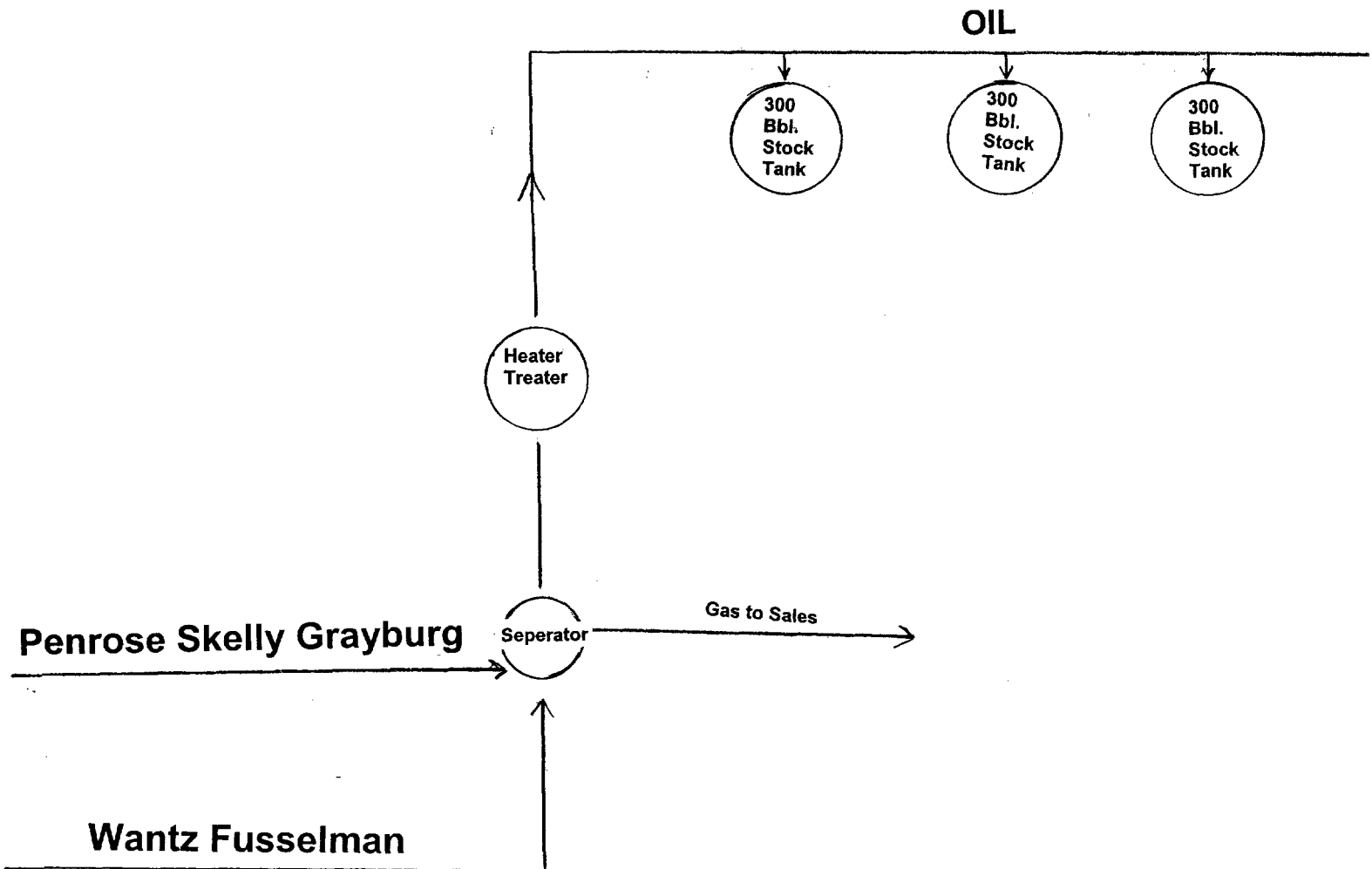
