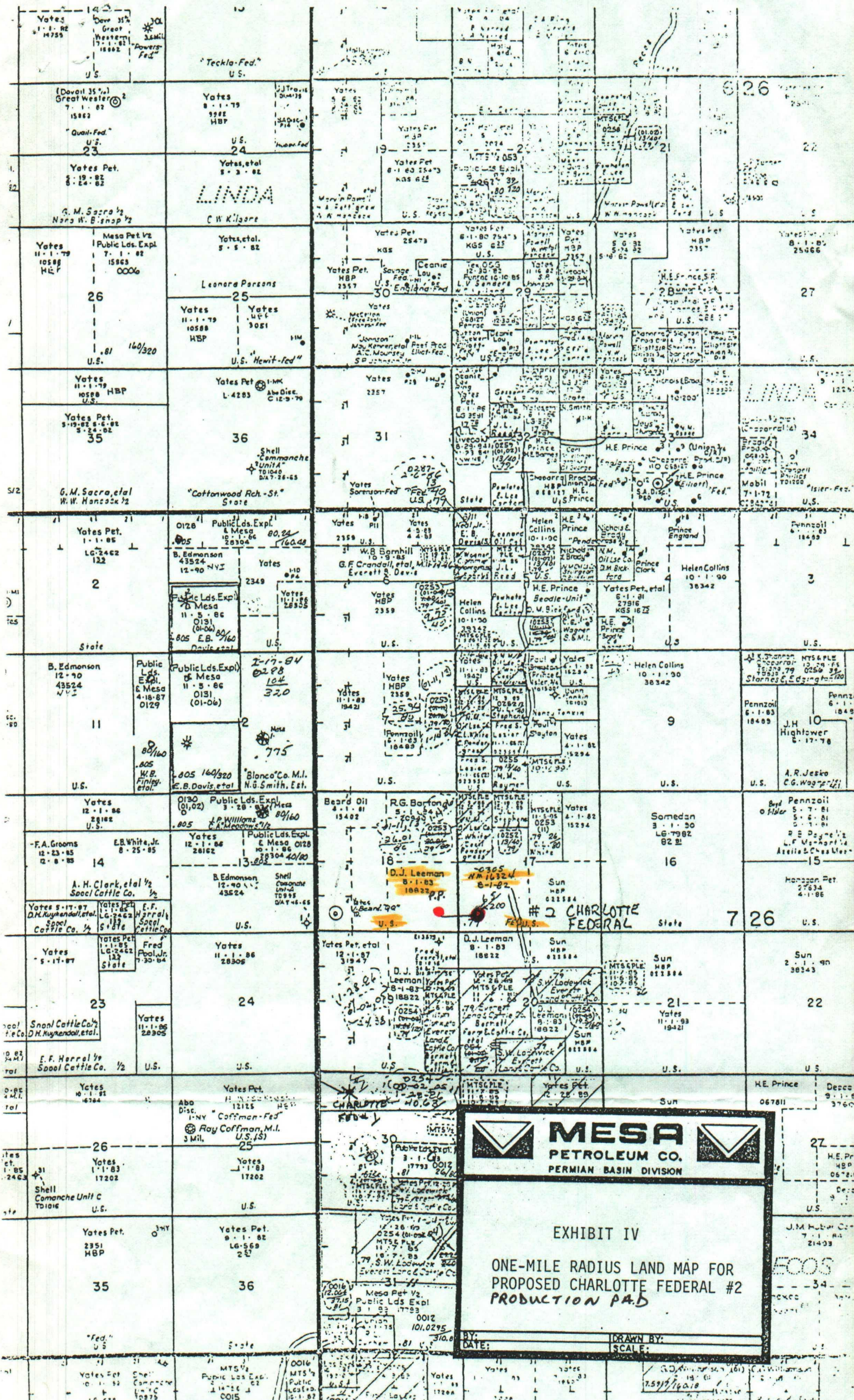


Special Stipulations NM-16324
Charlotte Federal

1. No production facilities, except the well head, will be allowed in flood plain.
2. Any drilling fluids produced while drilling must be hauled off and not left to stand & dry in the flood plain.
3. No produced fluids will be allowed to be discharged in the flood plain or river. If excess fluids are produced during drilling operations, these fluids will be hauled off.
4. Pile-ons will be placed around the well head to protect structure on the flood plain.
5. If well is a producer it will be equipped with a automatic shut-off system in case of high water.
6. The line from the well head to any production equipment will be buried.

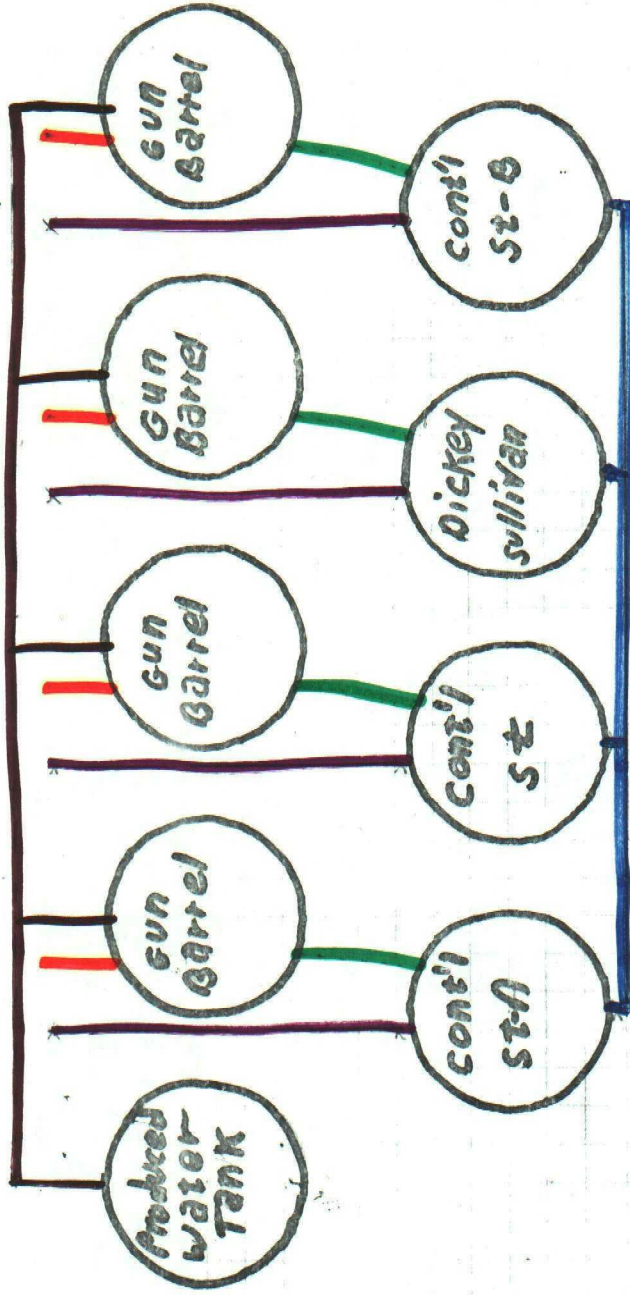
