Dear Sir:

Amerada Petroleum Corporation requests permission to store on the W. E. Mathers lease crude oil produced from the J. T. Caudle No. 6, located in Unit K, Sec. 3, T-12S, R-33E, Lea County, New Mexico.

The tanks that are planned to be used were previously used for the W. E. Mathers, Devonian, which has declined in production until the tanks are no longer needed. The other tanks on the W. E. Mathers are used for W. E. Mathers Lower Penn. oil production, Upper Penn. condensate production and Devonian oil production. There is no comingling of the production on the Mathers lease.

Service Pipe Line Company is the purchaser of the oil and Warren Petroleum Corporation is purchaser of the casing head gas from the Caudle No. 6. Both companies have connections at the W. E. Mathers battery. There is also a salt water disposal connection at the battery. Since the tanks and connections are already in place and connected, off lease storage would result in considerable savings to Amerada, Service Pipe Line Co. and Warren Petroleum Corp.

Verbal approval for off lease storage has been received from the United States Geological Survey and the New Mexico Oil Conservation Commission offices in Hobbs, New Mexico.




