Sinclair Oil & Gas Company requests an exception to Eule 309-A to permit off-lease storage on our State "L" DE lease, Vacuum Glorieta production.

It is proposed to locate the battery for this lease on our State B-1578 lease (adjoining) in order that production can be handled through a Multi-Lease LACT Unit. State B-1578 lease is the E/2 of NW/4 of Sec. 30, T17S, R35E, Lea County, New Mexico. This production will not be commingled, but it will be handled by use of separate metering through Multa-Lease LACT for sale to the pipeline company.

The attached plat shows location of the two leases as well as proposed location of the off-lease storage. Upon approval of the off-lease storage for the State "L" DE lease, an application will be submitted to use multi-lease LACT equipment as described above.

In the event further information is required to complete this application, please advise.


