RE: Off-Lease Storage, Dayton Townsite, Atoka (San Andres) Field

Dear Mr. Ramey:

We are now drilling San Andres wells in the Dayton Townsite and seek Administrative Approval under the provisions of OCC Rule 309C to set up individual tank batteries in a centrally located area for the several leases.

An existing tank battery for our Dayton "ER" No. 1 is located in Unit I of Section 21-185-26E. We propose that separation and storage facilities for Dayton development leases DX, EY, EZ and EX others (East half of Section 21) be located alongside the Dayton ER tank battery in Unit I and which will be more than 4 mile from existing occupied dwellings and approximately 1000 feet from a Transformer station.

The following requisites for off-lease storage are met:

- 1. All production is from the same common source;
- 2. Commingling of production will not result;
- 3. There will be no intercommunication of the handling, separating, treating, or storage facilities designated to each lease;
- 4. The working interest owners are the same and Yates Petroleum as Operator waives objections;
- 5. An ownership plat of the area: is attached.
