
Administrative Order PC-3 which authorized this commingling is hereby cancelled.

Administrative Order PC-3

Gentlemen:

Reference is made to your application dated March 11, 1960, for administrative approval of an exception to Rule 303 (a) of the Rules and Regulations of the Oil Conservation Commission to permit the commingling of the oil produced from the Bronco Siluro-Devonian Pool and the Bronco Mississippian Pool from all wells presently completed or hereafter drilled on its Barnes and Golden lease comprising the SW/4 of Section 11, Township 13 South, Range 38 East, Lea County, New Mexico.

By the authority vested in me under the provisions of Rule 303 (b) of the Rules and Regulations of the Oil Conservation Commission, I hereby authorize you to commingle the oil production from the Bronco Siluro-Devonian Pool and the Bronco Mississippian Pool from all wells presently completed or hereafter drilled on the above-described Barnes and Golden lease after separately metering the production from each pool.

There shall be no common line connecting the metering separators.
