Gentlemen:

Your letter of September 25 requests approval to modify the commingling system approved by our letter of September 3, 1968, for that portion of lease Las Cruces 031736(b) in the NE $\frac{1}{4}$  sec. 21 and the NW $\frac{1}{4}$ , NW $\frac{1}{4}$ NE $\frac{1}{4}$ , and NW $\frac{1}{4}$ SE $\frac{1}{4}$  sec. 22, T. 20 S., R. 37 E., Lea County, New Mexico. You propose to add Weir Drinkard pool production from well No. 13, in the SW $\frac{1}{4}$ NE $\frac{1}{4}$  sec. 22, to presently commingled Monument Grayburg-San Andres pool, Weir Blinebry pool, Monument Tubb pool, and Cass Pennsylvanian pool production.

The system for commingling described by the diagram attached to your letter is hereby approved. The addition of any other well to the system or any other change in the system must receive prior approval from this office.

Please notify our Hobbs office when the installation is completed so that a field inspection of the system can be made.

Gentlemen:

Our letter dated August 26, 1968, File: VES-341-541.112 x 400, Subject: same as above, requested amendment to Administrative Order PC-111 to permit the commingling of production from the Gillully "B" Federal Well No. 12, Cass Penn Oil Pool, with production from the Monument, Monument Tubb, and Weir Blinebry Oil Pools.

Subsequent to the above date, the Gillully "B" Federal Well No. 13, located in Unit G, Section 22, T-20-S, R-37-E, has been completed as a marginal oil producer in the Weir Drinkard Oil Pool. On potential test the well pumped and flowed 70 BO and 236 BW in 24 hours, CGR 34.

It is respectfully requested that further consideration be given to the Amendment of Administrative Order PC-111, providing for the commingling of the Weir Drinkard production with the other pools' production being commingled into our Gillully "B" Federal Commingled Battery No. 2, located in the SW/4 NE/4 of Section 21, T-20-S, R-37-E.

For all practical purposes the actual commercial value of the total commingled production shall remain approximately the same with no loss in revenue being sustained.

A plat of the Gillully "B" Federal Lease showing all wells and the formation in which completed, and a schematic diagram of the proposed commingling facilities are attached.

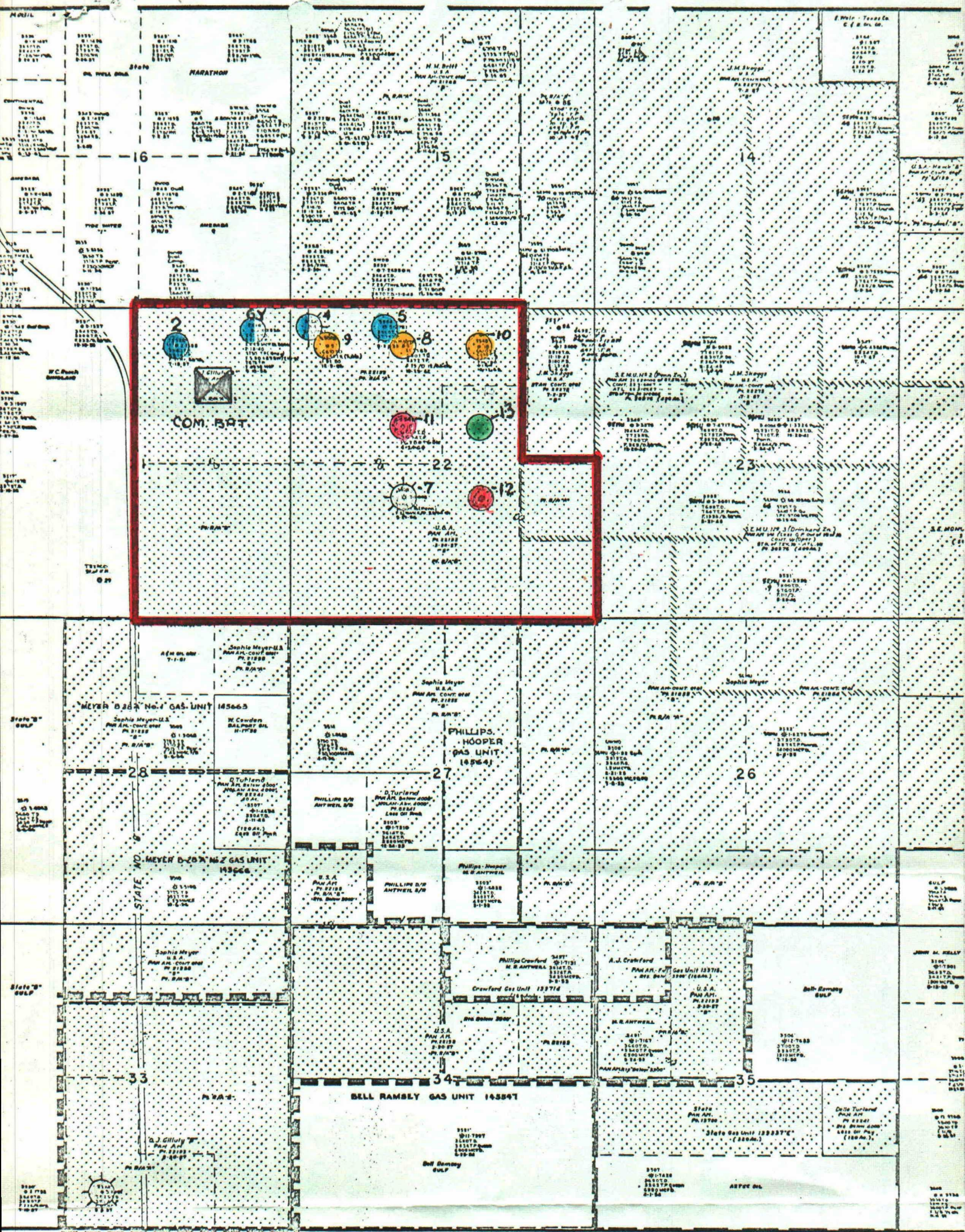

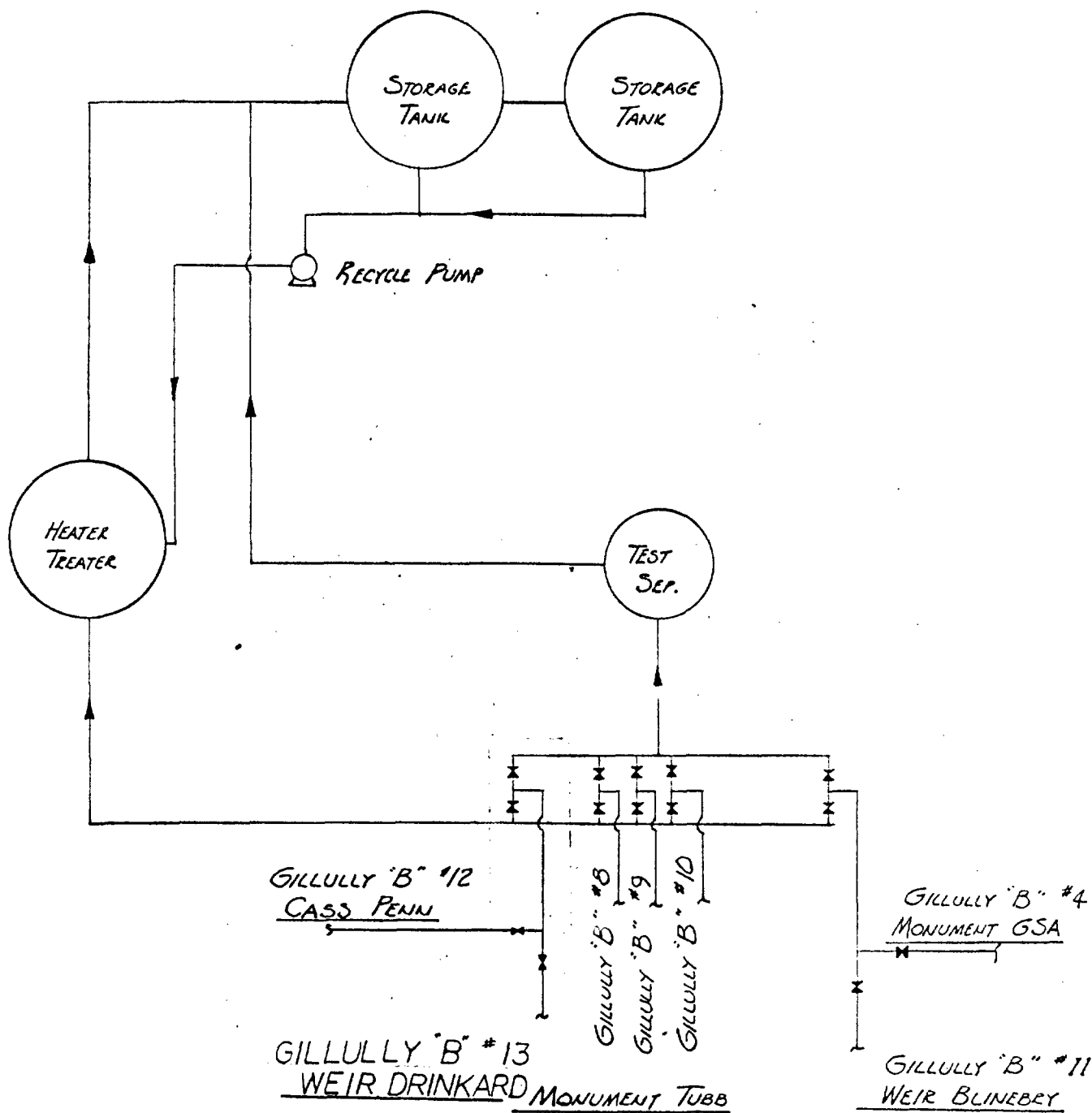
