Y Reference is made to your application dated August 16, 1967, wherein you request that Administrative Order PC-247 which authorizes the commingling of Blinebry oil, Drinkard oil, and Tubb condensate on your S. E. Cone Lease which comprises the N/2 SE/4 of Section 26, Township 21 South, Range 37 East, Lea County, New Mexico, be amended to permit the inclusion of Wantz Abo oil in the installation. All production from each zone would be metered with the exception of the Tubb condensate which is determined by means of the subtraction method.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, Administrative Order PC-247 is hereby amended to permit the inclusion of said Wantz Abo production.
