Gentlemen:

Cities Service Oil Company proposes to install a Lease Automatic Custody transfer Unit and commingle crude oil at the Clara Fowler Lease, located NE/4, Section 31-T18S-R38E, Lea County, New Mexico. It is requested that administrative exceptions be granted to Rules 303(a) and 309-A.

Two zones are productive on the Fowler Lease. Wells No. 1 thru 4 produce from the Hobbs San Andres and Wells No. 5 thru 8 produce from the Bowers Seven Rivers. Oil production from each zone will be kept separate until metered and sampled in compliance with state rules. The proposed ACT and commingling facilities will be located at the current tank battery site.

The volumes of oil from each pool, based on April, 1966 production, are as follows:

Hobbs Pool - San Andres	167.8 bbls. per day
Bowers Pool - Seven Rivers	13.9 bbls. per day
T ota l	181.7 bbls. per day

The expected gravity ...e commingled crude is calculated at 35.1 degrees API which wil /ield \$503.31 daily at \$2.77 per barrel.
