

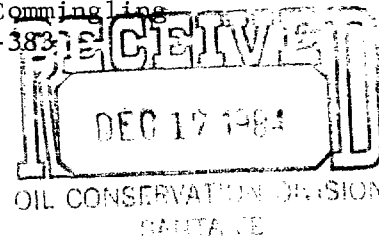

Gentlemen:

Subject order authorized surface commingling of the Blinebry, Drinkard, Wantz Abo and Wantz Granite Wash production in a common tank battery on Gulf's Drinkard (NCT-B) Lease, Section 30-22S-38E, Lea County, New Mexico.

The Drinkard (NCT-B) Well No. 6, Unit P, Section 30-22S-38E, was recompleted in 1978 and has been erroneously carried in the Wantz Abo Pool since that time. As advised by the Hobbs Oil Conservation Division Office (see letter attached), the well is actually in the South Brunson Abo Pool and all records are being corrected accordingly.

It is requested that subject order be amended to delete the Wantz Abo Pool and include the South Brunson Abo Pool production on the Drinkard (NCT-B) Lease.
