Gentlemen:

In the House San Andres Pool, Well #1 E 12-20S-38E has been off production and has been put back on. The operator requests administrative approval to commingle the oil production in common storage from the wells listed above by exception to Rules 309-A and 303-A.

The interests are identical in all 3 wells. The gravity of the oil is 33° currently valued at \$11.35 per barrel, and no decrease in value or gravity is expected after commingling. Production from all three wells should amount to a total of six or seven barrels per day.

Plats showing location of the wells, flow line and storage facilities are enclosed.

These wells are sub-marginal. Form C-116's showing production capability for allocation purposes are enclosed.
