Gentlemen:

Pool Commingling - Pearsall BX Lease

Continental Oil Company proposes to commingle the production from the Pearsall Queen Pool with the production from the Maljamar Grayburg San Andres Pool on its Pearsall BX Lease. This lease is located in Section 34, T-17S, R-32E, Lea County, New Mexico.

Well No. 3 produces 6 BOPD, 21 BWPD and 4 MCFGPD from the Maljamar Grayburg San Andres Pool. The gravity of this crude is 39.1. Well No. 2 produces 32 BOPD, 0 water and gas. The gravity of this crude is 38.4.

The royalty owner in both these wells is the United States Government. There will be no royalty lost as a result of this commingling.

Attached is a schematic showing the proposed commingling facility, a lease plat identifying the wells involved and showing location of proposed commingled battery and a letter of approval from USGS.

Your early approval of this proposed commingling is respectfully requested.










-LEGEND-
