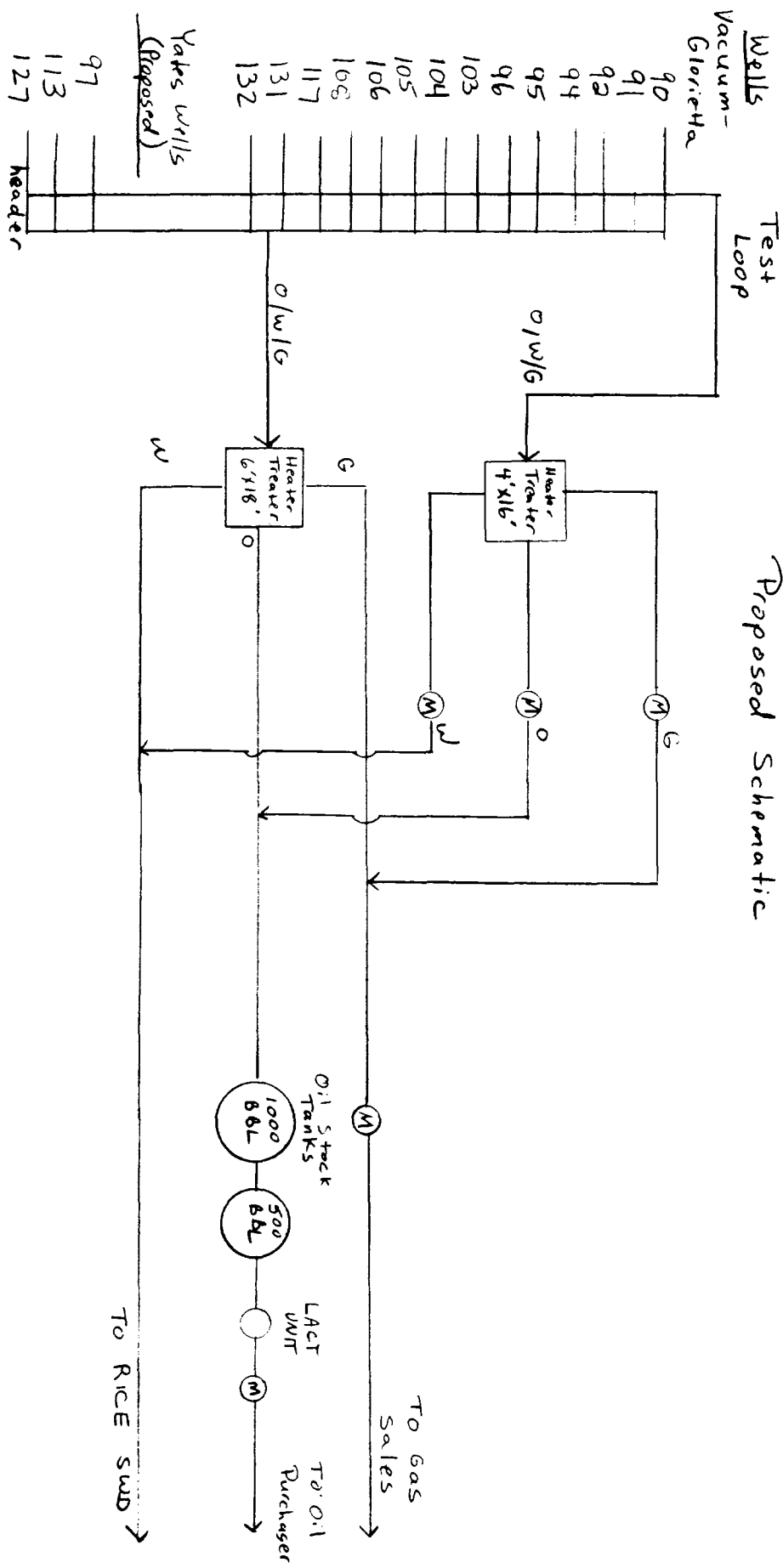

# Santa Fe Tank Battery No. 17 Proposed Schematic

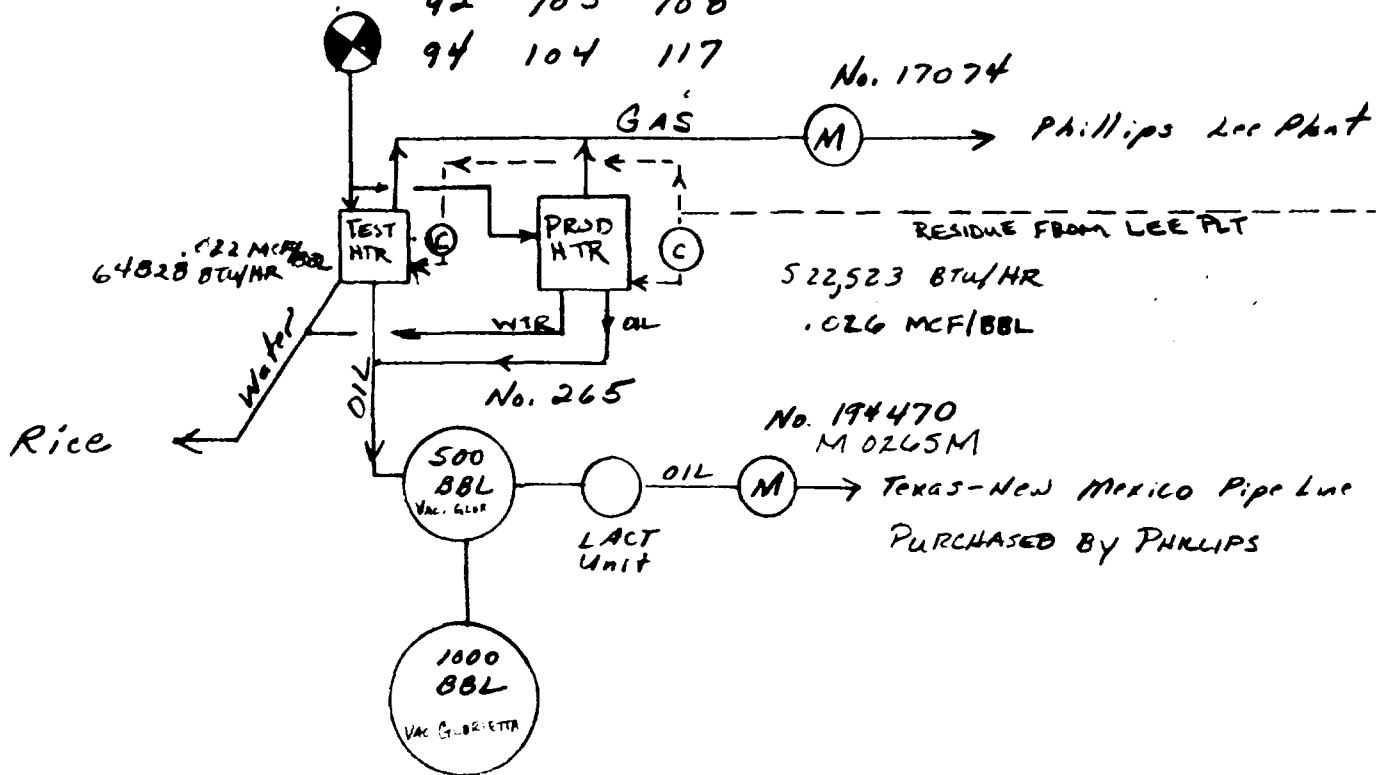

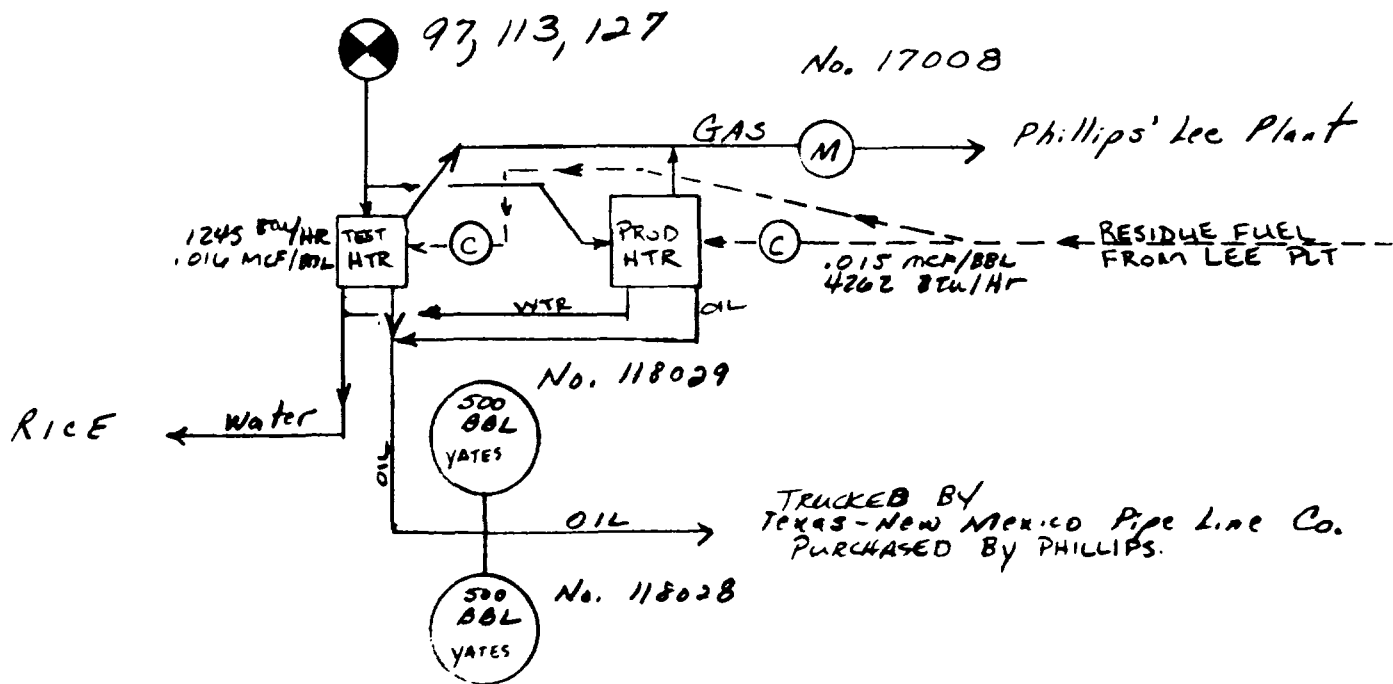

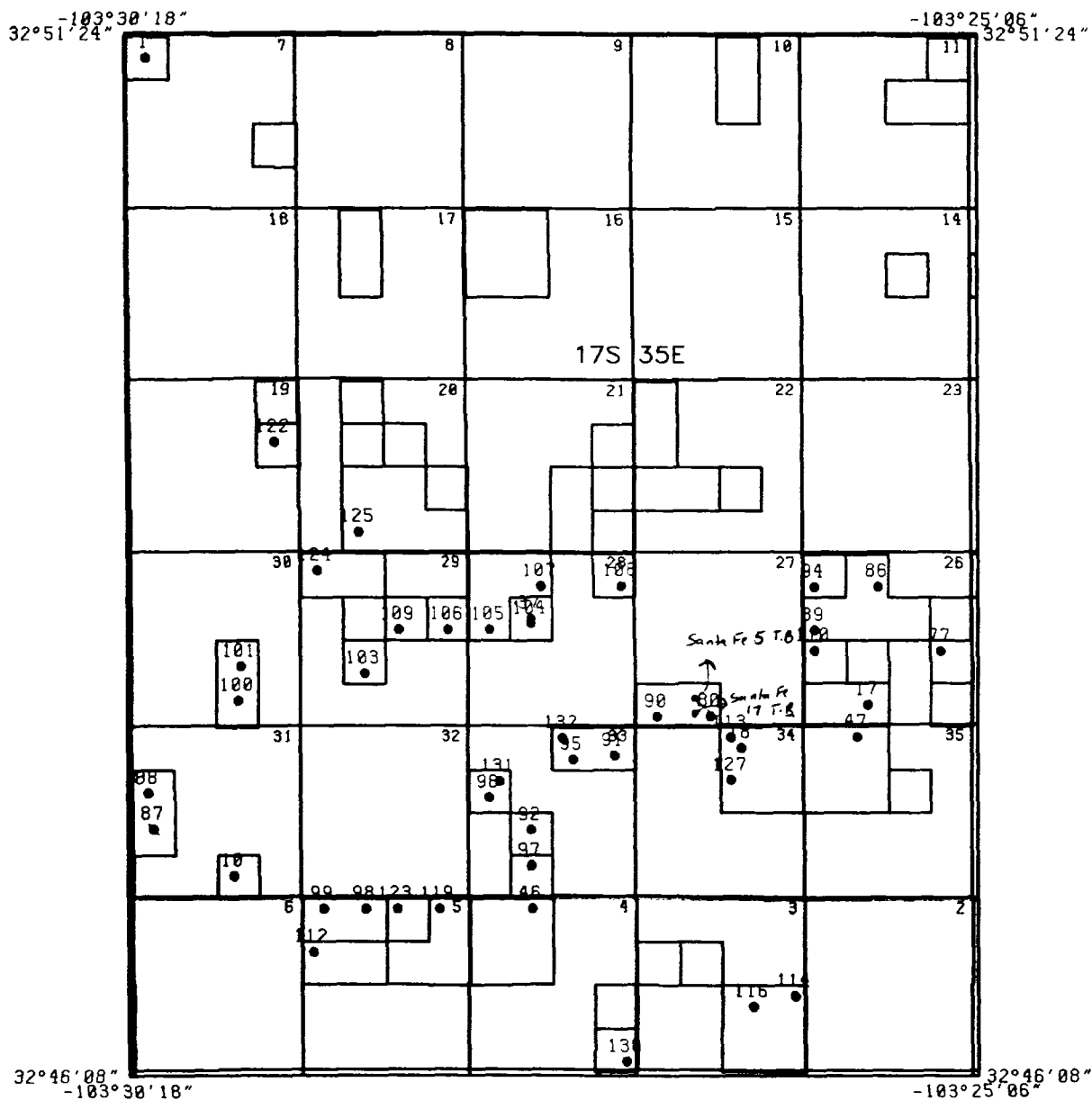
