North Teague Ellenburger and Undesignated Fusselman Pools

Section 9, T-23-S, R-37-E Lea County, New Mexico

Gentlemen:

Texaco Exploration and Production Inc. respectfully requests permission to surface commingle produced hydrocarbons from the North Teague Ellenburger and Undesignated Fusselman pools on the referenced lease. B. F. Harrison B Well No. 3 was recently drilled and completed in the Fusselman at a rate of 208 BOPD, 0 BWPD, and 92 MCFD. It is proposed to commingle this oil at the lease battery with current Ellenburger production of 900 BOPD.

The current Ellenburger production does not include production from Well No. 5 which was recently drilled and is currently being completed as an Ellenburger well. Please include Well No. 5 in this application and if circumstances warrant the application will be amended to reflect the completion of Well No. 5 in another zone.

Texaco owns 100% working interest in both zones on the lease. A common royalty of 12.5% applies for both zones on this fee lease.

Attached is a plat showing the location of the wells and battery on the Harrison Lease. Also attached is a schematic of the lease battery where monthly tests will be accurately measured on a per well basis. Total monthly production will then be allocated to each well utilizing the subtraction method. Detailed data of the oil gravities, average crude production and sales value on a per pool basis has been tabulated and is included for your approval.
