Gentlemen:

Reference is made to your request dated May 14, 1964, for authority to commingle San Andres and Paddock production from your State 5-27 Lease and San Andres, Paddock, and Yates production from your State 4-27 Lease in Section 27, Township 17 South, Range 35 East, Lea County, New Mexico.

No action has been taken on this application inasmuch as we have not yet received the approval from the Commissioner of Public Lands for the State of New Mexico to this commingling.

We assume that your application of May 14 supersedes your previous application dated April 27, 1964. An inspection of both applications, however, reveals that no schematic diagram of the actual commingling installation has been filed, and we are unable, from the word description of the installation in the application, to determine if the installation will comply with the Commission "Manual for the Installation and Operation of Commingling Facilities." Please submit the aforesaid schematic diagram and we will be happy to process the application upon receipt of approval from the Commissioner of Public Lands.

Gentlemen:

Standard Oil Company of Texas, a Division of California Oil Company, respectfully requests administrative approval to commingle San Andres and Paddock production from the State 5-27 (B-1839) Lease with San Andres, Paddock, and Yates production from its State 4-27 (B-1840) Lease. All wells are located in Section 27, Range 35 East, Township 17 South, Lea County, New Mexico and have identical working interests and royalty interests. Following is a resume' of this production:

The State 5-27 San Andres production will be processed through existing metering and separation facilities located on the lease prior to being transferred to tankage on the State 4-27 Lease. The State 5-27 Paddock production, at present one well with probable maximum of four wells, will be moved directly to the State 4-27 battery site where metering and separation facilities are installed.

The State 4-27 Lease production from four San Andres, four Paddock, and a single Yates producer will be processed through existing facilities and commingled in the State 4-27 battery.

Production will be prorated to the individual wells through periodic well tests utilizing metering separator on the two leases.





Gentlemen:

Administrative Order PLC-12 authorizes commingling of San Andres, Paddock and Yates production on our State 5-27 and State 4-27 Leases in Section 27, Township 17 South, Range 35 East, Vacuum Field, Lea County, New Mexico. The Commission now designates the Paddock zone to be in the Vacuum (Glorieta) Field; therefore, the Paddock production referred to in our request dated May 14, 1964, and in administrative order PLC-12 is actually Glorieta Production.

It is respectfully requested that Order PLC-12 be amended to authorize commingling of "San Andres, Glorieta and Yates production" instead of "San Andres, Paddock and Yates Production".

Reference is made to your letter of November 13, 1964, addressed to our Hobbs office, wherein you state that the Vacuum Glorieta production from your State 4-27 and State 5-27 Leases will in the future be handled by a separate ACT unit to be transferred to Texas-New Mexico Pipeline Company's sweet crude line. This production is currently being commingled with the Vacuum Yates and Vacuum Grayburg San Andres production.

Administrative Order CTB-121, which originally authorized the commingling of the Glorieta production from the two subject leases, allocating the production upon the basis of periodic well tests, is hereby reinstated. Administrative Order PLC-12, which authorized the commingling of production from the three zones underlying the two leases, is hereby amended to delete the Glorieta production from the commingling authority contained therein.

ALTERATION OF COMMINGLING PRACTICE,
PLC-12 AND ACT PERMIT NO. I-121
VACUUM (YATES), (GRAYBURG-SAN ANDRES)
AND (GLORIETA) FIELDS

Gentlemen:

Negotiations have been completed and pipeline approval received for the sale of Standard's Vacuum (Glorieta) Field production on State 4-27 and 5-27 leases as sweet crude rather than to the sour line as presently occurring. This will effect an increase in royalty amounts to the State and, of course, to Standard. To facilitate such arrangement an alteration will be required in our commingling practice as authorized by PLC-12. Also a change will be called for in the amount and origin of crude delivered through the ACT unit covered by ACT Permit No. I-121.

Under PLC-12, records should be altered to reflect that only Vacuum (Yates) and (Grayburg-San Andres) Field production from Standard's State 4-27 and 5-27 leases will be commingled, with the same metering, testing and storage facilities as were previously inspected and approved by your office. This combined crude will go to three 500 bbl storage tanks on the State 4-27 battery site (these are the same tanks used for emergency storage to the LACT under present arrangements). The daily amounts of oil involved here will be 325 - 350 BPD which will be sold conventionally from this tankage to Texas-New Mexico's sour crude line.

The Vacuum (Glorieta) Field production from State 4-27 and 5-27 leases will be kept separate throughout its metering and treating. It will be stored in three separate 500 bbl tanks, from which it will be sold through the presently operating ACT unit (covered by ACT Permit No. I-121) to Texas-New Mexico's sweet crude line.

It is felt no formal applications for change in these two matters are required. Basically it is planned to remove the Glorieta production

from the commingling authority and remove the Yates and Grayburg-San Andres
