Southland Royalty Co. <u>Aztec 22 Federal Lease (NM-0997)</u> Well No. 2, South Corbin Wolfcamp Field LACT located in Unit Letter F, Sec. 22, T-18-S, R-33-E Lea County, N.M.

Meridian Oil Inc. <u>Percha 15 Federal Com (NM-21171)</u> Well No. 3, South Corbin Wolfcamp Field L, Sec. 15, T-18-S, R-33-E Lea County, N.M.

Southland Royalty Co. and Meridian Oil Inc. request approval to surface commingle the Aztec 22 Federal Well No. 2 and the Percha 15 Federal Com well No. 3.

Plats are attached showing the location of each well and the location of the LACT. A schematic diagram of the battery is also attached.

The following are the estimated amounts of production for each well:

Aztec 22 Federal Well No. 2 105 BOPD, 380 MCFPD, 40.5 gravity, Wolfcamp Zone.

Percha 15 Federal Com. Well No. 3 417 BOPD, 300 MCFPD, 40.5 gravity, Wolfcamp Zone

The production for these wells will continuously run through a metered heater treater. This is the method we will allocate the production from each well.

Southland is 100% working interest owner for the Aztec 22 Federal No. 2.

Meridian is 100% working interest owner for the Percha 15 Federal Com. No. 3

These wells do not have identical ownership as far as the royalty interest and overriding royalty interest. The following is the % for each well:

Federal Royalties will not be reduced as wells will be continuously metered. Both wells produce from the same Field and Reservoir and have the same gravity.

Additionally, we request off-lease storage approval from the Percha 15 Federal Com. Well No. 3 to the Aztec 22 Federal Battery located in F, Sec. 22, T-18-5, R-33-E, Lea County, N.M.

I called Mr. Pete Martinez with the Commissioner of Public Lands Office on 9-11-92 and asked Mr. Martinez if this application needed to go through the State Land office since the Percha 15 Fed Com. Well No. 3 has a communitization agreement involving state land. Mr. Martinez said because the location of the well is on Federal Land and production is going to a Federal lease that the State Land Office did not need to approve this.
