# <u>A P P L I C A T I O N</u>

Comes now CONTINENTAL OIL COMPANY, a Delaware Corporation, hereinafter called "Applicant" and respectfully requests the Oil Conservation Commission of the State of New Mexico to issue orders authorizing Applicant to dually complete its W. C. Hawk B-10 No. 2-E well, and allocate a non-standard proration unit to the well, located 1980 feet from the North line and 1980 feet from the East line of Section 10, T. 21S, R. 37E, N.M.P.M., Lea County, New Mexico, in the Brunson Oil Pool and the Blinebry Gas Pool, and in support thereof would show the following:

A non-standard proration unit of 120 acres consisting of contiguous quarter quarter sections, NW/4 and S/2 of the NE/4, Section 10, T. 215, R. 37E, is requested. In support of this request we should like to point out that the proposed unit conforms with Commission requirements in all respects as follows:

- 1. Said unit consists of contiguous quarter quarter sections (and/or loss).
- 2. Said unit lies wholly within a single governmental section.
- 3. The entire proposed unit may be reasonably presumed to be productive of Blinebry gas.
- 4. The length or width of said unit does not exceed 2640 feet.
- 5. Copies of this application have been furnished by registered mail to all offset operators and all operators within 1500 feet of said well.

The dual completion of said well in the Ellenburger formation for oil and the Blinebry formation for gas is in the interest of conservation and the protection of correlative rights.

Segregation of the producing intervals will be made by appropriate packer installation and said well will be equipped so there can be no comingling of well fluids in producing the gas through the annulus between the tubing and casing, and the oil through the tubing. Said well will be equipped in such a minner that reservoir pressures may be determined separately for each of the two specified pools and the well head equipment to be equipped with all necessary connections to permit accurate measurement of any natural Hess, oil, or oil and gas produced ifrom each separate pool as may be required by the Commission.

Attached to this application is a plat showing the location of said well and surrounding wells and leaseholds with the acreage to be assigned the proposed gas unit antilized in red and a plat showing the mechanical condition of said well at present and after the proposed dual completion<sub>9</sub>

All offset operators have been duly notified by copy of this application.







THE APPLICATION OF CONTINENTAL CIL COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS W. C. HAWK "B-10" WELL NO. 2-E, LOCATED IN THE CENTER OF THE SW/L NE/L OF SECTION 10, TOWNSHIP 21 SOUTH, RANGE 37 EAST, NHPM, LEA COUNTY, NEW MEXICO IN THE BLINEBERY GAS POOL AND THE BRUNSON POOL.

### ALMINISTRATIVE OR IKR OF THE OIL COMPARENTICS COMMISSION

Under the provisions of Order No. R-316, Rule 112-A, Continental Cil Company made application to the New Mexico Oil Conservation Commission on March 9, 1956 for permission to dually complete its W. C. Hawk "B-10" Well No. 2-E, located 1980 feet from the North and East lines and in the Sul/h NE/h of Section 10, Township 21 South, Range 37 East, HMPM, Los County, New Mexico, in the Blinsbry Cas Pool and the Brunson Pool.

### The Secretary-Director Finds:

(1) That application has been duly filed under the provisions of Subsection 'c' of Rule 112-A of the Commission's Rules and Regulations;

(2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and

(3) That no objections have been received within the waiting period as prescribed by said rule.

### IT IS THEREFORE ORDERID:

That the applicant, herein, Continental Oil Company be and it hereby is authorized to dually complete its W. C. Hawk "B-10" Well No. 2-E, located in the SW/h NE/h of Section 10, Township 21 South, Hange 37 East, NMPM, Lea County, New Mexico in such manner as to permit production of gas from the Ellinebry formation of the Elinebry Gas Pool from proper perforation of the casing through the casing-tubing annulus and the production of oil from the Ellenburger formation of the Brunson Pool by proper perforation of the casing through the tubing and the installation of a suitable packer and with the installation of adequate surface equipment to maintain complete separation of the two zones of production.

PROVIDED HOWEVER. That subject well shall be completed and thereafter produced in such a senser that there will be no commingling within the wellbore, either within or outside the casing, of gas, oil and gas, or oil produced from either or both of the separate strata,

PROVIDED HOWEVER, That prior to the actual dual completion the operator shall make pressure tests of the casing to prove that no casing leaks have developed since the well was originally completed. In the event a casing leak is apparent the operator shall take appropriate steps to adequately repair the leak. The results of these tests shall be reported to the Commission on Form C-103.

PROVIDED FURTHER, That upon the actual dual completion of such subject well applicant shall submit to the District Office of the Commission at Hobbs, New Mexico, copies of Oil Conservation Commission Form C-103, Form C-104, Form C-110 and Form C-122 outlining the information required on those forms by existing Rules and Regulations and two copies of the electric log of the well, if available. -2-DC-287

PROVIDED FURTHER, That said subject well for dual completion and production shall be equipped in such a way that reservoir pressures may be determined separately for each of the two specified strata, and further, be equipped with all necessary connections required to permit recording meters to be installed and used, at any time, as may be required by the Commission or its representatives, in order that natural gas, oil, or oil and gas from each separate stratum may be accurately measured and the gas-oil ratio thereof determined, and

PROVIDED FURTHER, That the operator-applicant shall make any and all tests, including segregation tests, but not excluding other tests and/or determinations at any convenient time and in such manner as deemed necessary by the Commission; the original and all subsequent tests shall be witnessed by representatives of the Commission and by representatives of offset operators, if any there be, at their election, and the results of each test properly attested to by the applicant herein and all witnesses, and shall be filed with the Commission within ten days after completion of such test, and

<u>FROVIDED FURTHER</u>, That upon the actual dual completion of such subject well, applicant shall submit to the Commission a diagrammatic sketch of the mechanical installation which was actually used to complete and produce the seal between the strats, and a special report of production, gas-oil ratio and reservoir pressure determination of each producing zone or stratum immediately following completion.

IT IS FURTHER ORDERED, That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after proper notice and hearing the Commission may terminate the authority hereby granted and require applicant or its successors and assigns to limit its activities to regular single-zone production in the interests of concervation.
