Dear Mr. Bohling:

Due to inadvertence it would appear that Division Administrative Order NSP-317-A, dated February 18, 1992, which authorized a non-standard Eumont Gas spacing and proration unit comprising the NE/4, N/2 NW/4 and SE/4 SW/4 of Section 24, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico within Chevron's Harry Leonard (NCT-J) Lease does not state the intended order of the Division.

The third paragraph on page 2 of said order shall be corrected to read in its entirety as follows:

"By authority granted me under the provisions of Rule 2(a)4 of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170 as amended, a 280-acre non-standard gas spacing and proration unit in said pool comprising the NE/4, N/2 NW/4, and SE/4 NW/4 of said Section 24 is hereby approved."

All other provisions of said Administrative Order NSP-317-A shall remain in full force and effect until further notice.

Administrative Order NSP-317-A

Dear Mr. Bohling:

By Division Administrative Order NSP-317, dated September 19, 1956, Gulf Oil Corporation was authorized a 320-acre non-standard gas spacing and proration unit in the Eumont Gas Pool comprising the N/2 of Section 24, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico, in which was dedicated the Harry Leonard (NCT-J) Well No. 1 located at a standard gas well location 1980 feet from the North and East lines (Unit G) of said Section 24.

Reference is now made to your application dated January 17, 1992 to reduce said 320-acre unit by deleting the SW/4 NW/4 (Unit E) of said Section 24, which is to be utilized as a 40-acre oil spacing and proration unit in the Eumont Oil Pool for your Harry Leonard (NCT-J) Well No. 2 located 1980 feet from the North line and 990 feet from the West line of said Section 24.


