Gentlemen:

In accordance with Rules 3 and 5 of Order R-522 of the Special Pool Rules and Rule 112-A of Order 316 of the Commission's Rules and Regulations, I am hereby applying for a non-standard proration gas unit covering the NE/4 of Section 32, T-20S R-36E, NMPM, Lea County, New Mexico.

The Bell Oil Company Ltd. No. 1 Sinclair-State is located 1980' from the north line and 1980' from the east line in location G of said Section 32. The well was completed as a gas well in the Basal Yates Sand formation from perforations at 3857' to 3872'.

I believe that administrative approval of this application will tend to promote the conservation of gas and the better utilization of reservoir energy, and that the State will receive its fair share of the recoverable gas in place.

A contract for the sale of this gas has been negotiated with El Paso Natural Gas Company and they are presently preparing to lay a line into this well.

Due to the fact that subject lease expires February 10, 1958 your earliest attention to this matter will be greatly appreciated.
