Gentlemen:

Please consider this the application of Shell Oil Company for an 80-acre non-standard gas proration unit to be dedicated to Shell Livingston No. 9, Blinebry (Gas) Field, Lea County, New Mexico. As seen on the attached plat, this well is located 2208 feet FWL and 915 feet FSL of Section 3, T-21-S, R-37-E, Lea County, New Mexico.

Shell Livingston 9 was completed as a Blinebry (Gas) producer in October, 1953. Currently, 120 acres (outlined in red on the attached plat) are dedicated to this well. However, Shell Livingston No. 3, located within this 120-acre unit, was recently recompleted in the Blinebry (Oil) Field, resulting in this request of an 80-acre gas unit for Shell Livingston No. 9. The outline of the proposed 80-acre unit is shown in green on the attached plat.

Please advise if any other information is desired concerning this request.

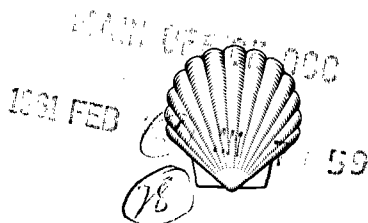

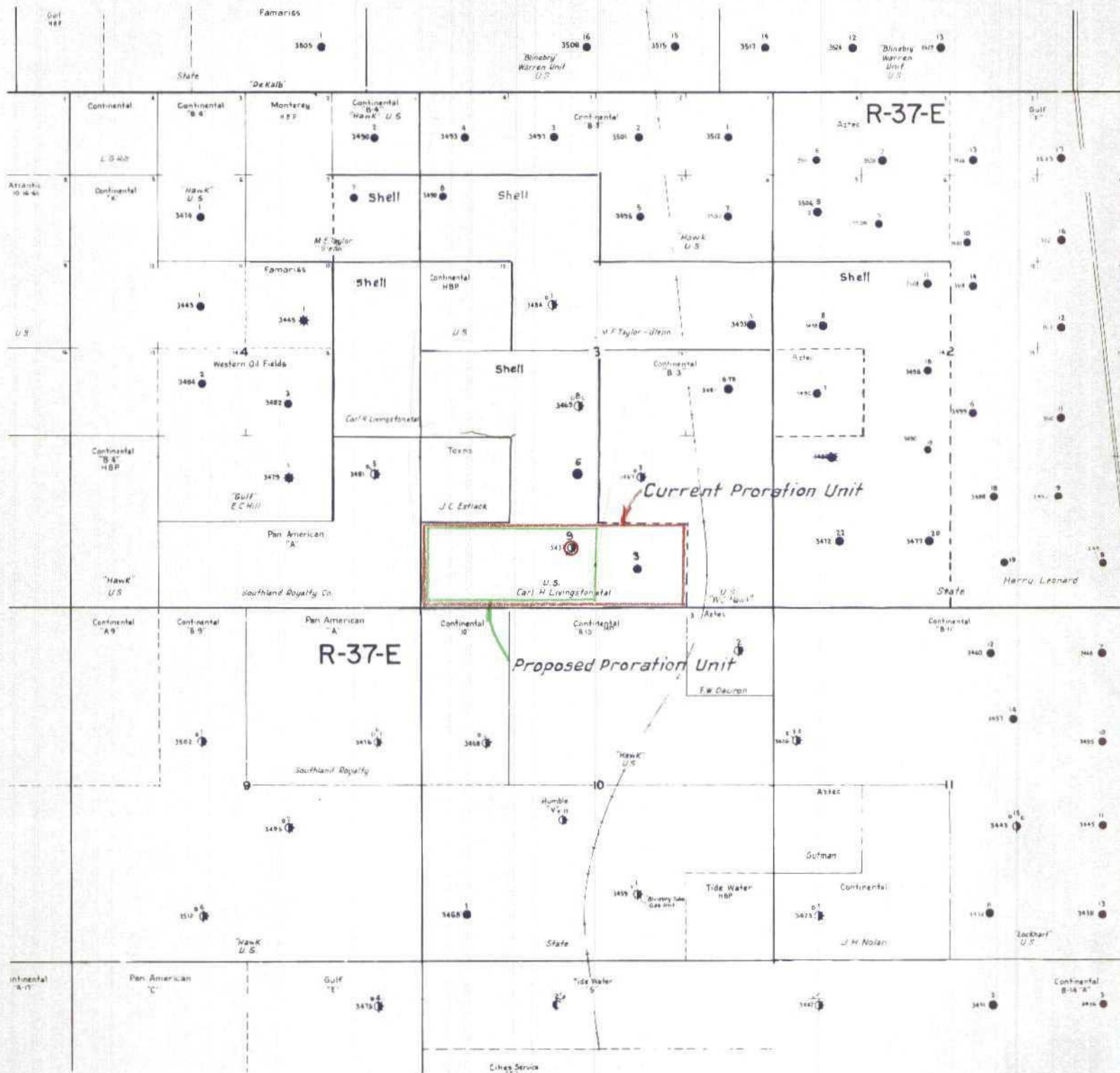
