Re: Application by Marathon Oil Company for Suspension of a 160 Acre Non-Standard Proration Unit and Assignment of a 120 Acre Non-Standard Proration Unit for the J. L. Muncy Well No. 2, Blinebry Gas Pool, Lea County, New Mexico

Gentlemen:

Marathon Oil Company, an Ohio Corporation, with offices at Hobbs, New Mexico, respectfully requests administrative approval of a 120 Acre non-standard gas proration unit in the Blinebry Gas Pool, Lea County, New Mexico, as an exception to Rule 5 (A) as permitted by Rule 5 (C) of the General Rules for Prorated Gas Pools of Southeastern New Mexico, Order No. R-1670.

The non-standard proration unit for which approval is sought is comprised of the SW/4 NE/4, NW/4 SE/4, and the NE/4 SW/4 of Section 24, T.22S, R.37E.

In support of this application the following facts are submitted:

- 1. Applicant is the operator of the oil and gas rights under the S/2 NE/4, SE/4, and the E/2 SW/4 in the aforementioned Section, Township and Range.
- 2. Applicant recompleted the J. L. Muncy Well No. 2 in July and August of 1958. Permission was granted to dual complete the well in the Blinebry and Tubb Gas Pools by NMOCC Order No. DC-630 dated July 7, 1958. The present 160 Acre non-standard proration unit assigned to the well in both the Blinebry and Tubb Gas Pools is comprised of the S/2 NE/4, NW/4 SE/4, and the NE/4 SW/4 of Section 24, T.22S, R.37E. This non-standard unit was authorized by NMOCC Orver No. R-1232 signed August 6, 1958.

- 3. Applicant received permission to drill and complete the J. L. Muncy Well No. 4 (location: SE/4 NE/4, Section 24, T.22S, R.37E) as a triple Blinebry Oil/Tubb Gas/Drinkard Oil well in NMOCC'S Order No. MC-1809 dated February 11, 1968. In the course of completing the well a Drinkard Oil completion was effected from perforations at 6423' to 6933', the Tubb Gas was found to be economically unproductive and thus squeezed off, and a Blinebry Oil completion was effected from perforations at 5565' to 5679'. The Blinebry perforations are well within the vertical limits described in NMOCC Order No. R-1670, Rule No. 25 from Special Rules and Regulations for the Blinebry Gas Pool and test data qualifies the well to be classified as a Blinebry Oil Pool well as described in Rule 27-A and 27-B.
- 4. In order to avoid acreage dedication for the Muncy No. 2 well in both the Blinebry Oil and the Blinebry Gas Pools in the SE/4 NE/4 of Section 24, T.22S, R.37E and in order to comply with Rule 29 Special Rules for the Blinebry Gas Pool, Order No. R-1670, applicant respectfully requests that the SW/4 NE/4, NW/4 SE/4, and the NE/4 SW/4 of Section 24, T.22S, R.37E being 120 Acres more or less, be designated as a non-standard proration unit in the Blinebry Gas Pool.
- 5. Creation of the above proposed 120-Acre non-standard proration unit is in the interest of conservation and will protect correlative rights.
- 6. A plat showing the said Marathon Oil Company's J. L. Muncy Lease, the wells thereon, the acreage to be dedicated to the No. 2 well and the offset ownership is attached hereto.


