Gentlemen:

The State "S" Wells Nos. 3 and 8 were reclassified to Blinbry Gas Wells effective January 1, 1972 in order to comply with provisions of Order No. 1670 pertaining to the Blinbry Gas Pool. Getty Oil Company requested an 80 Acre Non-Standard Gas Unit, as outlined in red on the attached C-102, be assigned to State "S" Well No. 3 located in Proration Unit B of Section 15. This 80 Acres being N/2 NE/4 of Section 15, T-21-S, R-37-E, Lea County, New Mexico. The request was granted by Administrative Order No. NSP-853 dated January 21, 1972. The 80 Acre Non-Standard Gas Proration Unit was allocated to State "S" Well No. 3.

We respectfully request that this 80 Acre Non-Standard Gas Proration Unit being the N/2 NE/4 of Section 15, T-21-S, R-37-E, as outlined in red on the attached C-102, be allocated to the State "S" Well No. 3 (Unit B) and Well No. 8 (Unit A) located in Section 15, the allowable from which to be produced from either well in any proration.
