
Dear Mr. Burleson:

Per your application dated February 19, 1992, you are hereby authorized to simultaneously dedicate Jalmat Gas Pool production to the previously approved non-standard 160-acre gas spacing and proration unit comprising the NW/4 of Section 28, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico (Division Administrative Order NSP-1034), from the following three Saunders Estate Lease wells all located at standard gas well locations within said unit:

- Well No. 1 - 1980' FNL - 660' FWL (Unit E)
- Well No. 2 - 1650' FN & WL (Unit F)
- Well No. 3 - 660' FN & WL (Unit D)

Further, you are hereby permitted to produce the allowable assigned said 160-acre unit from all three wells in any proportion.
