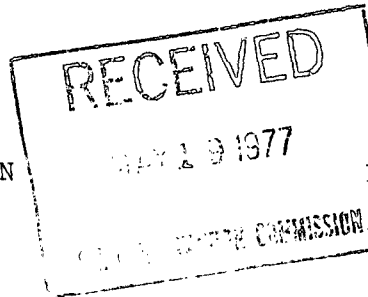

Gentlemen:

We are currently completing our No. 2 Woolworth well as a gas producer from the Yates formation in the Jalmat Gas Pool. The well is located 1980 feet from the south and 1650 feet from the west lines of Section 33, T-24-S, R-37-E, Lea County. Our lease acreage consists solely of the N/2 SW/4 of Section 33, and we therefore request that you approve a non-standard gas spacing unit for our well in the Jalmat Gas Pool consisting of the N/2 SW/4 of Section 33. The requested non-standard unit was formerly a non-standard unit in the Jalmat Gas Pool for the Julian E. Simon No. 1 Woolworth well, now abandoned, situated on the same unit tract.

Three copies of plat showing the location of our well and our proposed spacing unit are enclosed. The proposed unit is outlined in red.

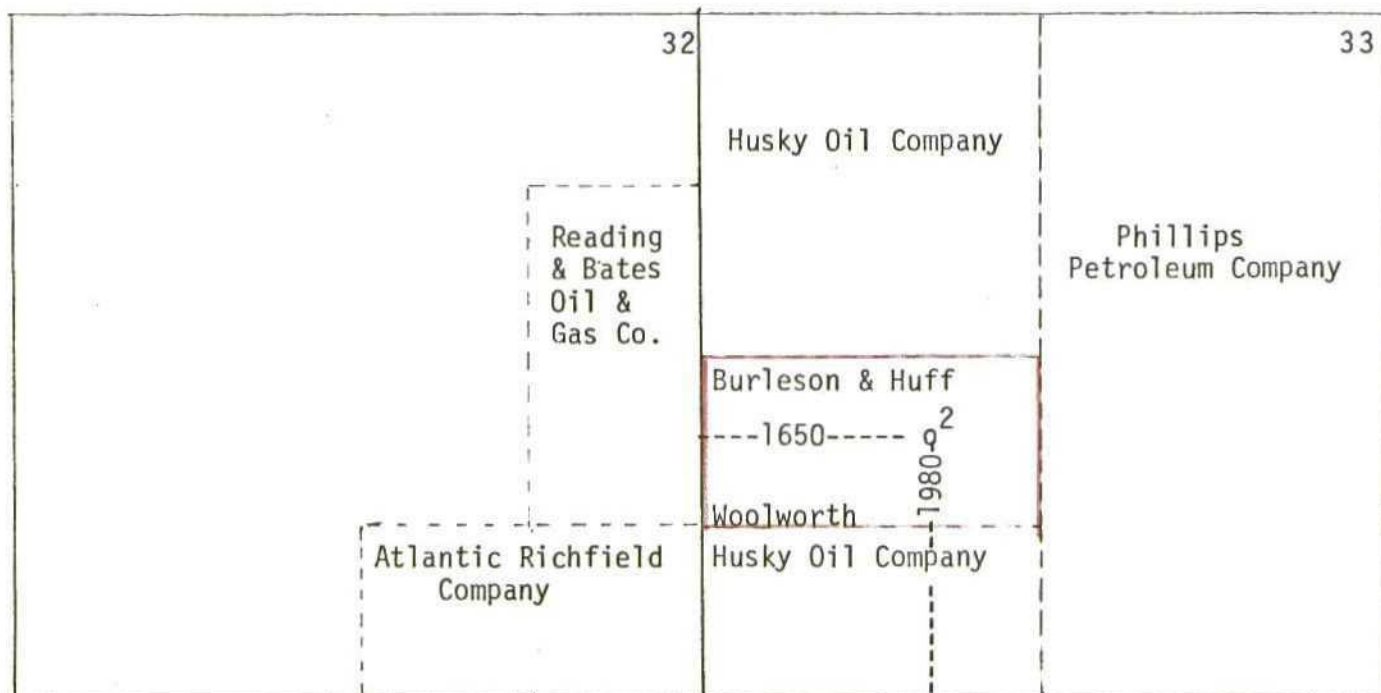
