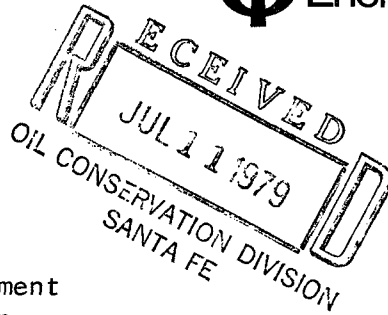

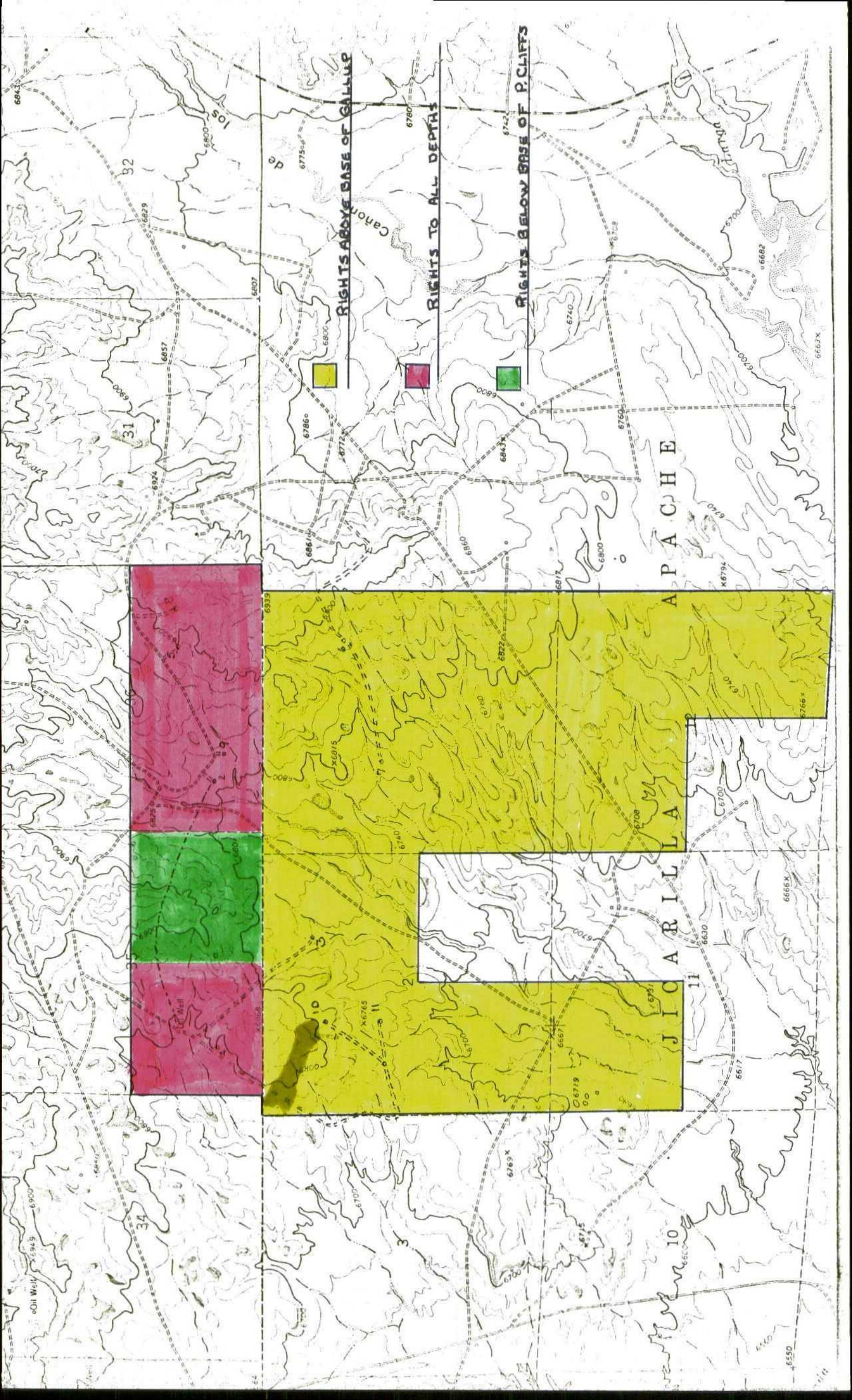
We may not process the subject application for a non-standard proration unit until the required information or plats noted below are submitted:

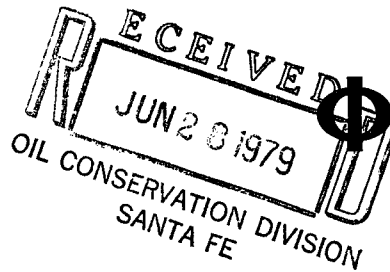

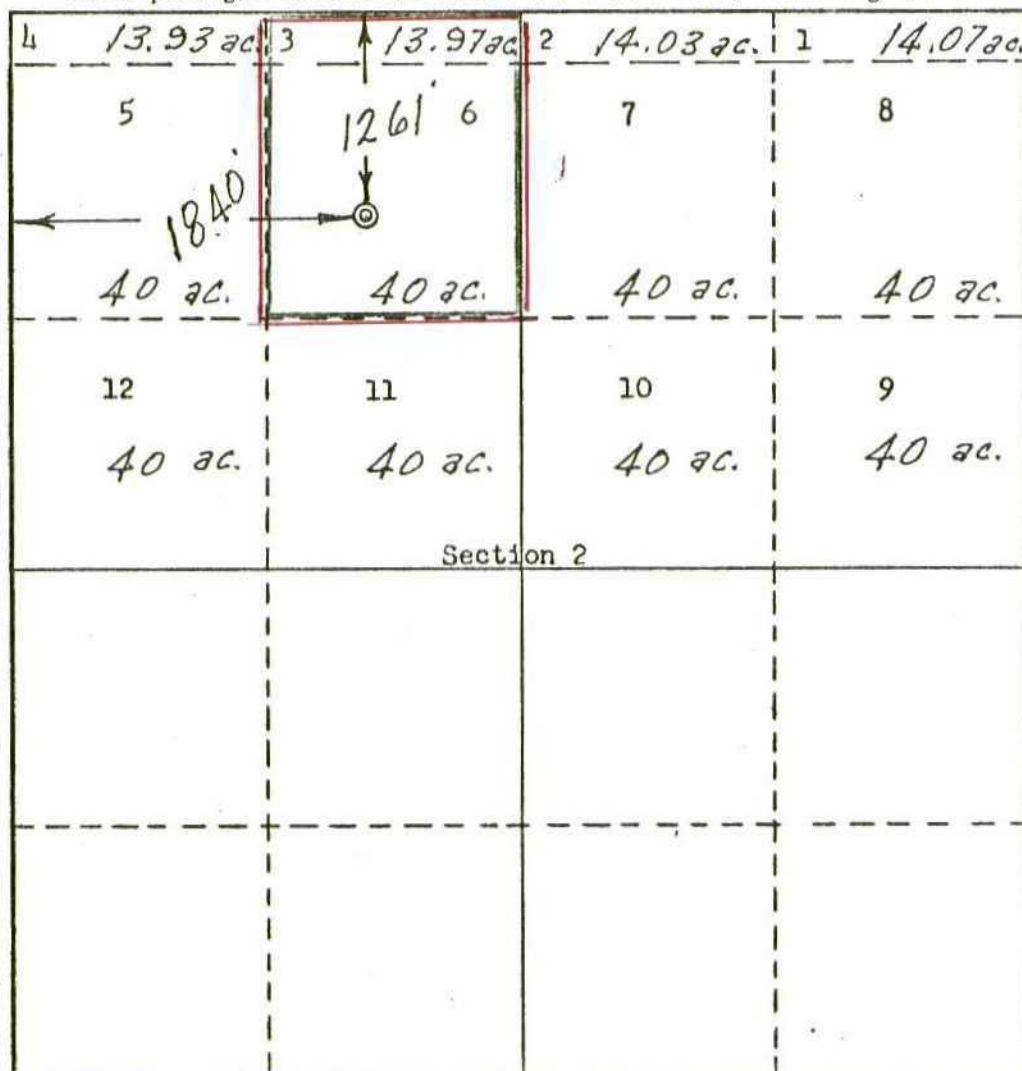
