Application for Non-Standard Proration Units Jicarilla Cont. Lease No. 155 Blanco Mesaverde Gas Pool Formerly - Gonzales Mesaverde Gas Pool Rio Arriba County, New Mexico



Amoco Production Company hereby makes application to the New Mexico Oil Conservation Division, pursuant to Rule 104 (D) II, for the administrative approval of Non-Standard Proration Units for wells located on the above captioned lease. This lease was developed with 160-acre dedication as part of the Gonzales Mesaverde Gas Pool. By Order R-7277, the New Mexico Oil Conservation Division has abolished the Gonzales Mesaverde Gas Pool and has incorporated those lands within the Blanco Mesaverde Gas Pool which requires a 320-acre gas proration unit. It is Amoco's desire to retain the current 160-acre dedication for each of these wells as a Non-Standard Proration Unit.

Enclosed is a Well Location and Ownership plat which shows the requested Non-Standard Proration Units. Amoco is the only operator owning interest in the half sections in which the Non-Standard Proration Units are situated. In addition, each of the requested Non-Standard Proration Units consist of contiguous quarter-quarter sections wholly within a single governmental half section. 
