Dear Mr. Catanach:

Mack Energy Corporation proposes to recomplete the referenced well in the Queen Formation in the Maljamar Queen (Gas) Field.

A standard proration unit to contain 160 acres would comprise the southeast quarter of the section, which would include 80 acres, being the south half of the southeast quarter which is leased by Conoco. Furthermore, the well is situated 2310' from the east line and 1650' from the south line of the section which is an unorthodox location.

We requested that Conoco join us in a 160 acre standard unit and they declined; however, they have agreed to waive any objection to the location (please see the attached letter from Conoco).

We wish to proceed with the recompletion of the well on a 80 acre proration basis (comprising the north half of the southeast quarter) with the understanding that we will receive a proportionately reduced gas allowance for the well.

Enclosed is a plat which identifies the location of the well and demonstrates that Conoco is the only other party which directly offsets the subject well.

We respectfully request administrative approval of our unorthodox location.


