Subsequent to my initial review of the subject application I find that more information will be required. Please submit a plat clearly showing the offset operators to the proposed non-standard unit. Also, were <u>all</u> of the interest owners in the W/2 NE/4 and SE/4 NE/4 of said Section 19 notified of this application (see Rule 4(b)(3) of the General Rules and Regulations for the Associated Oil and Gas Pools of Northwest and Southeast New Mexico, as promulgated by Division Order No. R-5353, as amended).

I understand my request is somewhat unusual, however I feel it is necessary considering the fact that Collins & Ware, Inc. operates the State "19" Well No. 1 in Unit A as an oil well in which the NE/4 NE/4 is already dedicated, and Rule 5(b) does not allow simultaneous dedication of any acreage to an oil well and a gas well. Further, said rule requires the Division to protect all interest owners in the remaining 120 acres contained in the NE/4.
