Administrative Order NSP-1715-A

Dear Ms. LeVan:

By Division Administrative Order NSP-1715(SD)(L), dated January 30, 1995, Chevion was authorized an 80-acre non-stand ard gas spacing and proration unit ("GPU") in the Blinebry Dil and Gas Pool comprising the W/2 SE/4 of Section 25, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico. Blinebry gas production from said unit to be simultaneously dedicated to the Amanda Well No. 1 (API No. 30-025-10449), located at a standard gas well location 1980 feet from the South and East lines (Unit J) of said Section 25 and the Amanda Well No. 3 (API No. 30-025-29975), located at an unorthodox gas well location for the aforementioned 80-acre spacing unit 330 feet from the South line and 1650 feet from the East line (Unit O) of said Section 25.

Reference is made to your application dated December 5, 1995 to reduce said 80-acre GPU by deleting the 40 acres comprising the SW/4 SE/4 (Unit O) of said Section 25. It is our understanding that Unit "O" is to be utilized as a standard "oil" spacing and proration unit in the Blinebry Oil and Gas Pool for the Amanda Well No. 3, which remained classified as an "oil well" after additional producing intervals within the Blinebry zone were opened up in the wellbore with additional perforations.

By authority granted me under the provisions of Rule 4(b)2 of the "Special Rules and Regulations for the Blinebry Oil and Gas Pool" as promulgated by Division Order No. R-8170, as amended, the following **40-acre** non-standard gas spacing and proration unit is hereby approved:

LEA COUNTY, NEW MEXICO <u>TOWNSHIP 22 SOUTH, RANGE 37 EAST, NMPM</u> Section 25: NW/4 SE/4.

Said 40-acre GPU is now to be dedicated to the above-described Amanda Well No. 1.

Further, said Division Administrative Order NSP-1715(SD)(L) shall be placed in abeyance until further notice.
