If you have any objection to the Division re-plugging this well, you should arrange to attend this hearing, or otherwise notify the Division of your objections prior to the scheduled date of the hearing.

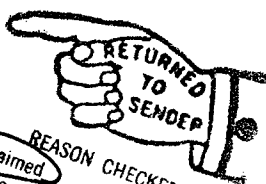
