1 WHEREUPON, the following proceedings were had at  
2 8:15 a.m.:

3 EXAMINER JONES: Let's go on the record and call  
4 this hearing to order. This is Docket Number 15-04. This  
5 is June 10th, 2004, Examiner Hearing. I'm Will Jones, and  
6 we have Mr. Mark Fesmire, our new Division Director, here  
7 with us today, and my supervisor, Richard Ezeanyim.

7 EXAMINER JONES: Thank you, Mr. Kellahin.

8 MR. KELLAHIN: There's an error in the well name,  
9 as well as in the description of the tract, and it's Unit  
10 Letter E. So we've changed the ad entirely and simply  
11 retained the same case number and ask that it be  
12 readvertised.

13 EXAMINER JONES: Okay, thank you, Mr. Kellahin.  
14 Any other continuances and dismissals? There being none,  
15 let's call the first case.


