1 WHEREUPON, the following proceedings were had at
2 9:07 a.m.:

3 CHAIRMAN FESMIRE: Good morning, we're going to
4 go ahead and call this meeting of the Oil Conservation
5 Commission to order.

6 Let the record reflect it's 9:07 on July 15th,
7 2004. The meeting is being held in Porter Hall at the New
8 Mexico Oil Conservation Division office in Santa Fe, New
9 Mexico.

10 My name is Mark Fesmire, I'm the Chairman.

11 To my left is Mr. Frank Chavez, a member of the
12 Commission.

13 To my right is Ms. Jami Bailey, she's also a
14 member of the Commission, she's the designee member of the
15 State Land Commissioner, Mr. Patrick Lyons.

16 On the far right is Florene Davidson, she's the
17 Commission secretary.

18 On the far left with the court-reporter equipment
19 is Mr. Steve Brenner. He's our official court reporter.

20 And let the record reflect that all Commissioners
21 or their designees are present.

22 At this time we're going to review the minutes of
23 the last meeting. Have the Commissioners had an
24 opportunity to review the minutes?

25 COMMISSIONER BAILEY: Yes, I have --

1 COMMISSIONER CHAVEZ: Yes.

2 COMMISSIONER BAILEY: -- and I move we accept
3 them.

4 COMMISSIONER CHAVEZ: I second the motion.

5 CHAIRMAN FESMIRE: The acceptance of the minutes
6 has been moved and seconded. All in favor?

7 COMMISSIONER BAILEY: Aye.

8 COMMISSIONER CHAVEZ: Aye.

9 CHAIRMAN FESMIRE: Opposed?

10 The minutes are hereby adopted for the June 17th
11 and 18th meeting of the New Mexico Oil Conservation
12 Commission.

15 CHAIRMAN FESMIRE: The first item on the agenda
16 today is Cause Number 13,269, the Oil Conservation
17 Commission will consider a proposed amendment to 19.15.1
18 NMAC adopting a new section to be codified as 19.15.1.21
19 NMAC concerning development in special portions of the
20 Chihuahuan Desert in southern New Mexico, in Otero and
21 Sierra Counties.

22 At this time we're going to have to take a quick
23 break. The Commission counsel has run up to get a copy of
24 the final Order and the amendment to the Order, and he will
25 be right back.

1 I didn't realize we would be done before he got
2 back, so if you want to take a quick break until he gets
3 back, I apologize, but feel free to stand up and stretch,
4 it's been so long.

5 (Off the record at 9:10 a.m.:)

6 (The following proceedings had at 9:23 a.m.:)

7 CHAIRMAN FESMIRE: Let's go back into session.

8 The Commission calls Cause Number 13,269, the Oil
9 Conservation Commission motion to adopt a new section of
10 19.15.1 NMAC, specifically to be codified as 19.15.1.21.

11 I have before me a draft order, and I'm going to
12 call on counsel Brooks to explain the draft order and the
13 addendum and the status of the case, please.

14 MR. BROOKS: Okay, may I see the Order? Thank
15 you.

16 Honorable Commissioners, Mr. Chairman, you will
17 recall the Commission deliberated at the conclusion of the
18 session on June the 18th and made certain changes in the
19 proposed Rule on the record.

20 The draft has been prepared to incorporate those
21 changes that were made on the record. I have the record of
22 the hearing here, in case any of the Commissioners would
23 like to refer to the record, in making sure that the
24 changes that were made in the rule were made in accordance
25 with the instructions given to counsel on the record at

1 previous hearing.

2 The only other thing which I believe requires
3 comment, since all of the Commissioners, or each of the
4 Commissioners separately, has had an opportunity to review
5 the draft order, I believe, prior to this hearing in
6 accordance with the Open Meetings Act; there have been no
7 discussions between the Commissioners, however -- as I
8 said, each of the Commissioners, I believe, has had an
9 opportunity to review this draft order -- the only other
10 thing that needs to be mentioned is with regard to the --
11 in my opinion at this point, and certainly I'll be glad to
12 respond to any questions that counsel may have -- but the
13 legal description of the area to which the Rule will apply.
14 There was some question about it raised at the previous
15 hearing, and the Commission instructed counsel to undertake
16 to review the matter, not for the purpose of determining to
17 what the Rule should apply, which of course is for the
18 Commission to determine, but inasmuch as there did not
19 appear to be any controversy about the area to which the
20 Rule should apply, then counsel was instructed to make a
21 study to determine -- to ascertain how that area could be
22 correctly described.

23 I have done that, and I have reviewed the matter
24 with the staff of the -- I have reviewed the maps, the
25 official maps prepared by the New Mexico State Land Office,

1 of which we have copies here in this Department, which I
2 have brought with me this morning in case any of the
3 Commissioners wants to look at them.

4 I have also reviewed plats of this area in the
5 office of the Bureau of Land Management down on Rodeo Road,
6 and I have discussed this issue with Mr. Joe Mraz at the
7 State Land Office and Mr. Glaze at the Bureau of Land
8 Management, and based on that review it is my professional
9 opinion that the area described in the proposed draft order
10 is the same area that is depicted in crosshach on Exhibit
11 4, which was introduced in evidence at the June 17th-18th
12 hearing, and I do not believe there was any other evidence
13 introduced on the issue of the particular area to which the
14 Rule should apply.

15 I have also discussed this with Commission
16 counsel, and I have provided my views to other counsel who
17 appeared in the case and asked for their comment but have
18 received none.

19 Otherwise, I think unless the honorable
20 Commissioners have any questions, to which I'm prepared to
21 respond, I believe that the draft order as it now exists
22 adopts the Rule in accordance with the changes made by the
23 Commission on June 18th.

24 CHAIRMAN FESMIRE: Commissioner Bailey, do you
25 have any comment?

1 COMMISSIONER BAILEY: My only comment is that I
2 will sign the Order, although I believe it's a shame that
3 the school children of New Mexico will be denied about \$40
4 million and that the economic development of a poor part of
5 a poor state will be -- will not occur.

6 CHAIRMAN FESMIRE: Commissioner Chavez?

7 COMMISSIONER CHAVEZ: I just had one question on
8 C.(8), the insertion of the "or" I think was a discussion
9 that we've had in looking over the drafts, the way it's
10 worded on this particular order.

11 I think we perhaps need to drop the word "or"
12 from that, because the way it reads it says, Operators
13 shall report injection pressures and volumes daily or in a
14 manner acceptable to the Division.

15 MR. BROOKS: Okay, this was a question that I
16 raised in an e-mail to each of the Commissioners. It's not
17 been previously discussed by the Commission, and
18 Commissioner Chavez is entirely correct, I had recommended
19 dropping the "or". However, I do not feel at liberty to do
20 so in view of a -- in the absence of a vote by the
21 Commission, because I had felt that might be a substantive
22 change.

23 My view of the matter was, from a drafting
24 standpoint -- and this specific language was dictated on
25 the record at the June 18th hearing -- my view from a

1 drafting standpoint is that the frequency of reporting is
2 one thing, the manner of reporting is conceptually
3 something else.

4 And to say they will -- when it says, Operator
5 shall report injection pressures and volumes daily or in a
6 manner acceptable to the Division, that suggests that the
7 Division might approve some manner other than daily, which
8 might be less frequently than daily, which I did not think
9 was the Commission's intent.

10 My view was that -- There was a lot of talk on
11 the record about continuous recording, and my view was that
12 continuous recording is, in effect, the same thing as daily
13 recording -- that continuous includes daily, since it's
14 more frequently. If you have a continuous record, you have
15 a daily record, was my view, and that the question is just
16 in how -- in what manner you will make the daily record.

17 So my view was that the overall intent that I
18 understood from the last meeting would be more correctly
19 stated if the "or" were dropped from that sentence.
20 However, as I said, I did not want to make that change
21 without the Commission having a chance to vote on it,
22 because it seemed to me that it could be interpreted as a
23 substantive change.

24 COMMISSIONER CHAVEZ: I think it's ambiguous with
25 the "or", as whether it means daily or instantaneous or

1 continuous, and I'd rather not be ambiguous. And I think
2 our intent was to have daily recording.

3 And we discussed the manner. The discussion
4 included, and I think even there was some testimony, that
5 instantaneous daily pressures or continuous reporting would
6 both be acceptable to the Division when asked about those
7 specifically.

8 So I don't know what the process is, and I would
9 move to strike the "or" from the Order and clear up that
10 ambiguity and allow the Division the latitude to determine
11 the manner of daily recording.

12 CHAIRMAN FESMIRE: Commissioner Bailey?

13 COMMISSIONER BAILEY: I'll agree with Mr. Chavez.

14 CHAIRMAN FESMIRE: Can I get that in the form of
15 a motion?

16 COMMISSIONER CHAVEZ: I move that the "or" be
17 struck from the Section C.(8), I guess it is, of the
18 proposed Rule.

19 COMMISSIONER BAILEY: I'll second that.

20 CHAIRMAN FESMIRE: All those in favor?

21 COMMISSIONER CHAVEZ: Aye.

22 COMMISSIONER BAILEY: Aye.

23 CHAIRMAN FESMIRE: Opposed?

24 We will strike the "or" from Section C.(8).

25 Are there any other comments on the proposed

1 Order and addendum?

2 MR. BROOKS: I have no further comments.

3 CHAIRMAN FESMIRE: At this point I would
4 entertain a motion to adopt the Order, with the one
5 subsequent -- with the one correction just entered on the
6 record.

7 COMMISSIONER CHAVEZ: I so move.

8 CHAIRMAN FESMIRE: Is there a second?

9 COMMISSIONER BAILEY: I'll second.

10 CHAIRMAN FESMIRE: All those in favor?

11 COMMISSIONER CHAVEZ: Aye.

12 COMMISSIONER BAILEY: Aye.

13 CHAIRMAN FESMIRE: Opposed?

14 The order is adopted as amended in this meeting,
15 and we'll go on to the next case on the docket.

16 Let the record reflect that the Order is being
17 signed.

18 MR. BROOKS: Is it the pleasure of the Commission
19 -- Mr. Chairman, honorable Commissioners, is it the
20 pleasure of the Commission, then, that the actual physical
21 change in the Order be made at the next break?

22 CHAIRMAN FESMIRE: I think it's such a small
23 change, can we just strike it on this copy and adopt it?

24 MR. BROOKS: Okay.

25 COMMISSIONER CHAVEZ: Just as a clarification, my

1 initial is T.

2 MR. BROOKS: My apologies, Mr. Chavez.

3 COMMISSIONER CHAVEZ: But that will be fine.

4 MR. BROOKS: Initial that, is that what you want
5 to --

6 CHAIRMAN FESMIRE: Please.

7 (Thereupon, these proceedings were concluded at
8 9:32 a.m.)
