

APPLICATION

Apache Corporation applies for an order contracting the horizontal limits of the Hare-San Andres Gas Pool, expanding the horizontal limits of the East Hare-San Andres Pool, and instituting special rules and regulations for the East Hare-San Andres Pool, located in Township 21 South, Range 37 East, N.M.P.M., Lea County, New Mexico, and in support thereof, states:

1. Applicant is an operator of wells completed in the San Andres formation within a mile of the East Hare-San Andres Pool.

2. The Hare-San Andres Gas Pool was created by Division Order No. R-4423, dated November 1, 1972, and currently covers the following acreage:

Township 21 South, Range 37 East, N.M.P.M.

Section 10:	S $\frac{1}{2}$
Section 15:	W $\frac{1}{2}$
Section 21:	S $\frac{1}{2}$
Section 22:	NE $\frac{1}{4}$ and W $\frac{1}{2}$
Section 27:	W $\frac{1}{2}$
Section 28:	S $\frac{1}{2}$

The Hare-San Andres Gas Pool is developed on statewide spacing, with 160 acre gas well units.

3. The East Hare-San Andres Pool was created by Division Order No. R-10776, dated March 1, 1997, and currently covers the following acreage:

Township 21 South, Range 37 East, N.M.P.M.
Section 10: SE $\frac{1}{4}$

The East Hare-San Andres Pool is developed on statewide spacing, with 40 acre oil well units.

4. Applicant has recently completed three San Andres wells in the S $\frac{1}{2}$ of Section 9 and the NW $\frac{1}{4}$ of Section 16, Township 21 South, Range 37 East, N.M.P.M. The wells are oil wells under Division regulations.

5. Applicant requests that the Hare-San Andres Gas Pool be contracted by deleting therefrom the following acreage:

Township 21 South, Range 37 East, N.M.P.M.
Section 10: S $\frac{1}{2}$

6. Applicant also requests that the East Hare-San Andres Pool be expanded by adding thereto the following acreage:

Township 21 South, Range 37 East, N.M.P.M.
Section 9: S $\frac{1}{2}$
Section 10: SW $\frac{1}{4}$
Section 16: NW $\frac{1}{4}$

7. Applicant further requests that special pool rules be instituted for the East Hare-San Andres Pool, providing for:

- (a) a gas oil ratio of 5,000 cubic feet of gas for each barrel of oil produced; and
- (b) all other rules to comply with statewide rules.

8. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the relief requested above be granted.
