





**Re: Application of Mission Resources Corporation for three infill gas wells and simultaneous dedication, Lea County, New Mexico.**

Ladies and Gentlemen:

This letter is to advise you that Mission Resources Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking an exception to the density requirements provided by the "Special Rules and Regulations for the Jalmat Gas Pool", as promulgated by Division Order No. R-8170, as amended, for its proposed State "A" A/C-2 Well Nos. 82, 83 and 84 to be drilled and completed in the Jalmat Gas Pool at infill gas well locations in Units J, n and O Section 11, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico.

Mission Resources Corporation pursuant to the "Special Rules and Regulations for the Jalmat Gas Pool" and the Stipulated Declaratory Judgment issued by the First Judicial District Court in Santa Fe County, New Mexico, on December 15, 2000, in Cause No. D-0101-CV9902927, also seeks authority to simultaneously dedicate the Jalmat production from the proposed new infill wells and the existing Jalmat gas wells identified in the enclosed application to the standard 640-acre Jalmat Gas Pool spacing and proration unit comprised of Section 11, Township 22 South, Range 36 East, NMPM.

This application has been set for hearing before a Division Examiner hearing on April 29, 2004 at Porter Hall located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87504. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date. Parties appearing in cases are required by Division Rule 1208.B to file a Pre-hearing Statement three days in advance of a scheduled hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
