APPLICATION OF MERIT ENERGY COMPANY FOR AN EXCEPTION TO DIVISION RULE 104.C.(2)(B), EDDY COUNTY, NEW MEXICO.

APPLICATION

Merit Energy Company applies for an exception to Division Rule 104.C.(2)(b) to allow (i) two gas wells to be located in the SW% of Section 34, Township 21 South, Range 26 East, N.M.P.M., Eddy County, New Mexico, and (ii) both wells to produce concurrently from the Strawn and Morrow formations. In support thereof, applicant states:

- 1. Applicant is the operator of the W% of Section 34 as to formations developed on 320 acre spacing.
- 2. The W% of Section 34 is currently dedicated to the State Q Com. Well No. 1, located 2235 feet from the south line and 660 feet from the west line (the NW%SW%) of the section, which is currently producing from the Strawn formation (Happy Valley-Strawn Gas Pool). Applicant also intends to re-complete the well in the Morrow formation (Happy Valley-Morrow Gas Pool), and to produce the well from both formations by means of downhole commingling.
- 3. Applicant proposes to drill the State Q Com. Well No. 2 at an orthodox location 660 feet from the south line and 1980 feet from the west line (the SE½SW½) of Section 34, to a depth sufficient to test the Morrow formation.
- 4. Applicant seeks approval to simultaneously dedicate the W% of Section 34 to both the State Q Com. Well Nos. 1 and 2, in both the Strawn and Morrow formations, and to produce both wells

concurrently.

- 5. The State Q Com. Well No. 2 is being located in the SE%SW% of the section for geological and topographical reasons. In particular, no surface occupancy is allowed in the NW% of Section 34.
- 6. The granting of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter an order granting the relief requested above.
