WHEREUPON, the following proceedings were had at 1 2 9:40 a.m.: EXAMINER STOGNER: The hearing will come to order 3 again. At this time I'll call Case Number 13,327. 4 the Application of XTO Energy, Inc., to amend Division 5 Order Number R-11,132-B for simultaneous dedication and an 6 7 unorthodox gas well location in San Juan County, New 8 Mexico. Call for appearances. 9 10 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe, 11 representing the Applicant. I have two witnesses. 12 EXAMINER STOGNER: Any other appearances? 13 Mr. Bruce, is this on tribal lands, this --MR. BRUCE: Yes, it's on Ute Mountain Ute tribal 14 lands, and Mr. Gordon Hammond from the Ute Mountain Utes is 15 in the audience. 16 17 EXAMINER STOGNER: I'd like to make note of that, that the Ute Mountain Ute tribal representative is here in 18 the audience today, and if you have any questions I'll open 19 20 it up and you'll be able to ask the question or make a 21 statement later, so don't feel shy. 22 Any other appearances on the record? 23 Okay, will the witnesses please stand to be 24 sworn? 25 (Thereupon, the witnesses were sworn.)

1 TIM WELCH, 2 the witness herein, after having been first duly sworn upon his oath, was examined and testified as follows: 3 DIRECT EXAMINATION 4 5 BY MR. BRUCE: Would you please state your name for the record? 6 0. Tim Welch. 7 A. Where do you reside? 8 Q. 9 Grapevine, Texas. A. Who do you work for and in what capacity? 10 Q. XTO Energy, Inc., as a division landman in Fort 11 Α. 12 Worth, Texas. Have you previously testified before the 13 Q. Division? 14 15 Yes, I have. Α. And were your credentials as an expert petroleum 16 Q. 17 landman accepted as a matter of record? 18 A. Yes, they were. 19 0. And are you familiar with the land matters 20 involved in this case? 21 Α. Yes, sir, I am. MR. BRUCE: Mr. Examiner, I'd tender Mr. Welch as 22 23 an expert petroleum landman. EXAMINER STOGNER: Mr. Welch is so qualified. 24 25 Q. (By Mr. Bruce) Before we begin, Mr. Welch, we're

6 1 seeking to amend an order that was issued in favor of Cross Timbers Oil Company. What is the relationship between 2 Cross Timbers and XTO? 3 We've had a name change. It's now XTO Energy, 5 Inc. Okay. Could you identify your Exhibit 1 and just 6 Q. briefly describe what is depicted on this plat? 7 Yes, sir, the Exhibit 1 is a nine-section plat 8 9 representing XTO's 100-percent working interest, leasehold 10 interest, as depicted in yellow, and it also shows the 11 three separate tribal leases that we own in the area, the Tribal "A" Lease, the Tribal "J" Lease, and the Tribal "D" 12

- Q. Is XTO the only working interest owner in these three leases?
  - A. That's correct.
- Q. And all three are Ute Mountain Ute Tribal leases, are they not?
- 19 A. That's correct.
  - Q. What is the royalty under each of the leases?
- 21 A. One-eighth.

- Q. Okay, so there -- Are there any overriding royalties on this acreage?
- 24 | A. No, sir.
- Q. So in other words, interest, royalty and working

interest is uniform throughout the nine sections in this 1 area? 2 Yes, sir. Now, beyond the nine-section area 3 there could be some differences, but in the offsetting area 4 to the southeast quarter of Section 2 that is the case. 5 Okay. Does this plat also depict all wells on 6 Q. these leases? 7 8 Α. Yes, it does. Okay. Now, let's concentrate on the southeast 9 Q. quarter of Section 2. There are four wells on this quarter 10 section, and we are here today regarding the A 27 well and 11 the A 32, but let's discuss these others first. 12 There's the A 26 well. What is the status of 13 that well? 14 That's a producing Paradox well. 15 Α. Okay. And that well is not involved in this 16 Q. 17 Application; is that correct? Α. That is correct, yes, sir. 18 There's also the A 20 well. What is the current 19 Q. status of that well? 20 21 Α. That well is plugged and abandoned. 22 Okay, so it has been recently plugged and Q. abandoned? 23 I believe it was plugged and abandoned in 2003, 24 25 yes, sir.

1	Q. Okay. Now with respect to the order, R-11,132-B,
2	that order approved the simultaneous dedication in the Ute
3	Dome-Dakota Gas Pool to the Well Numbers 20 and 32,
4	correct?
5	A. Yes, sir.
6	Q. And since the Number 20 well is plugged and
7	abandoned, you seek to amend the order to allow the
8	southeast quarter to be simultaneously dedicated to the
9	Well Numbers A 27 and A 32?
10	A. That is correct.
11	Q. In the Ute Dome-Dakota Gas Pool?
12	A. Yes, sir.
13	Q. Now, the A 27 well was originally drilled to what
14	formation?
15	A. Morrison formation.
16	Q. And that has been producing only in the Morrison;
17	is that correct?
18	A. Yes, sir.
19	Q. And I believe the prior order also approved the
20	unorthodox location for that well?
21	A. Yes, sir.
22	Q. Okay. Will the A 27 then be abandoned in the
23	Morrison and produced only from the Dakota?
24	A. I believe that will be the case initially, and
25	perhaps I should defer to our next witnesses as to plans

Now, the prior order or orders approved 3 Q. the unorthodox location for the A 27 in the Morrison 4 Is XTO now requesting approval of an unorthodox 5 formation. location in the Dakota formation for the A 27 well? 6 That is correct. 7 Α. And again, even though it is highly unorthodox, I 8 Q. believe the location is what, 2600 feet from the south 9 line? 10 11 Yes, sir. A. All of Section 2 is owned in common; is that 12 Q. correct? 13 That's correct. A. 14 15 Q. And so the unorthodox location will not adversely affect any interest owner? 16 Yes, sir. 17 Α. Now with respect to notice, Mr. Welch, three 18 Q. 19 entities were notified: the Ute Mountain Ute Tribe, 20 correct? Yes, sir. 21 Α. 22 And the federal Bureau of Land Management? Q. 23 A. That's correct. 24 In dealing with these lands, do you deal with Q. 25 both the Ute Mountain Utes and the federal Bureau of Land

# 1 Management? Α. Yes, we do. 2 And also there is a notice given to Jerry Simon 3 Q. of Data Consultants, Inc. What is his position? 4 It's my understanding that Jerry works as a 5 Α. consultant for the Ute Mountain Ute Tribe. 6 7 Okay, and all of those people were notified of Q. 8 this Application, were they not? 9 Α. Yes, sir, that's correct. Were Exhibits 1 and 6 prepared by you or under 10 0. 11 your supervision or compiled from company business records? 12 Α. Yes, sir. 13 And in your opinion is the granting of this Q. 14 Application in the interests of conservation and the 15 prevention of waste? 16 Α. Yes, sir. 17 MR. BRUCE: Mr. Examiner, I'd move the admission 18 of XTO Exhibits 1 and 6. 19 EXAMINER STOGNER: Exhibits 1 and 6 will be 20 admitted into evidence. 21 **EXAMINATION** BY EXAMINER STOGNER: 22 23 Q. Yes sir, Mr. Welch, in referring to Exhibit Number 1, the Well Number 32 and 26, they appear to have 24

been directionally drilled. Is that the blue indication,

those little blue lines? 1 Yes, sir, the -- I know it's hard to read, but 2 A. the blue dot would be the surface location. 3 Do you know why the configuration of the 4 directional drill and the necessity was? 5 It's my understanding it was due to faulting in 6 Α. 7 the area. Okay, so geological? 8 Q. Yes, sir. 9 Α. Okay. Subsurface? 10 Q. Exactly. There could have been some 11 A. 12 considerations for topography too, Mr. Examiner. I have to admit it's been awhile since I've visited that particular 13 issue, but it could have been twofold. 14 And that was what I was -- leading up to my next 15 Q. question, what are the surface concerns in this area, in 16 this nine-section area? 17 18 A lot of the topography out here has a lot of A. 19 relief to it, so it's very common to have some situations where we have to seek some relief because of adverse 20 conditions in trying to get a location built? 21 22 Now, that's just the topography that you're Q. 23 talking about or referring to at this point? 24 A. Yes, sir. How about other surface conditions that may 25 Q.

exist, archaeological?

- A. I'm not aware of any in this particular area, but I do know there are some concerns of that nature in some of our other locations throughout these leases.
- Q. Any other surface concerns that XTO or an operator out there contends with to satisfy the tribe or the BLM?
- A. Those three are the ones that I'm predominantly familiar with, Mr. Examiner. I'm not familiar with any others in recent history.
- Q. Now, you mentioned you had sent to the BLM -now, this is the BLM office out of the Durango area; is
  that correct?
  - A. Yes, sir.
- Q. Just for the record, why not the New Mexico BLM?

  This is an elementary question, but I need it for the record, and also the new supervisor that I have.
- Q. Historically, that's what we've been asked to do, and perhaps the next witness would have a better historical perspective than that, than I, but during my tenure with XTO the last five years, it has always been requested of us to deal with the Durango office for jurisdictional purposes.

EXAMINER STOGNER: Mr. Bruce, do you have any -- MR. BRUCE: I believe part of it may be that the

bulk of the Ute Mountain Ute Tribe is in Colorado, and I 1 would guess that they are the ones with primary -- the 2 3 Durango office is the BLM office with the primary jurisdiction --4 EXAMINER STOGNER: And the consistency of --5 MR. BRUCE: Rather than having it split up 6 7 between the Farmington and the Durango offices where there could be, you know, conflicting interpretation of 8 regulations, etc. 9 10 EXAMINER STOGNER: That's what I wanted to put into the record, because that's my understanding. And it 11 makes sense too, so -- Well, I guess it depends on which 12 13 BLM office you like dealing with better than the other. Q. (By Examiner Stogner) Now, Mr. Welch, you're not 14 -- naturally you're not proposing to -- or what you've 15 shown here, you're not proposing to drill any new 16 17 additional wells; these are just the rules and regulations that you contend with utilizing the existing wells in this 18 160-acre area? 19 Yes, sir, that is correct. 20 Α. 21 EXAMINER STOGNER: Any other questions of Mr. 22 Does anybody have any questions of this witness? Thank you, sir, you may be excused. 23 24 Mr. Bruce?

MR. BRUCE: Call Mr. Voigt to the stand.

BARRY VOIGT, 1 the witness herein, after having been first duly sworn upon 2 3 his oath, was examined and testified as follows: DIRECT EXAMINATION 4 5 BY MR. BRUCE: Would you please state your name for the record? 6 Q. 7 A. Barry Voigt. How do you spell your last name? 8 Q. 9 V as in Victor, o-i-g-t. A. 10 Q. Where do you reside? 11 Azle, Texas. A. 12 Who do you work for and in what capacity? Q. 13 XTO Energy, Inc., as a senior reservoir engineer Α. 14 in Fort Worth, Texas. 15 Have you previously testified before the Q. 16 Division? 17 Α. Yes, I have. 18 And were your credentials as an expert engineer Q. accepted as a matter of record? 19 20 Α. Yes. 21 Q. And are you familiar with the engineering matters 22 involved in this Application? 23 Α. Yes. 24 Q. Did you testify in the previous hearings 25 regarding these wells?

1 A. Yes. MR. BRUCE: Mr. Examiner, I'd tender Mr. Voigt as 2 3 an expert reservoir engineer. EXAMINER STOGNER: Mr. Voigt is so qualified. 4 (By Mr. Bruce) Mr. Voigt, could you identify 5 Q. Exhibit 2 for the Examiner and just briefly describe the 6 7 geology in this area? Exhibit Number 2 is a structure map of the top of 8 9 the Dakota sandstone. You do see the faulting in the blues 10 The blues are basically faults that are and oranges. 11 downdipping to the north, and the orange is downdipping to 12 the south. 13 Q. Is this the same -- basically the same map that 14 was presented in the prior hearings in this matter? 15 Yes, but just a different presentational format, Α. 16 since they changed computer programs for presentation. 17 Q. Okay, the data is the same --18 Α. Yes. 19 -- as previously submitted to the Division? Q. 20 Α. Yes. 21 And essentially because of the faulting, none of Q. 22 these wells is going to drain the entire southeast quarter; 23 is that the --24 Correct. Α. 25 -- essential geologic interpretation? Q.

Α. Correct. 1 And again, looking at the -- Okay, the numbers 2 Q. 3 are there. Again, the A 20 well has been P-and-A'd, correct? 4 Correct. 5 Α. Is the A 27 well still producing from the Morrow 6 Q. sand? 7 8 Yes, it is, at approximately 30 MCF a day. 9 Q. Okay. And what is the proposal? Are you just 10 going to complete in the Dakota and produce from the Dakota 11 at this time if approval is granted? 12 Yes, and if -- once the Dakota does deplete off 13 and pressures come down, we'll consider commingling the 14 Morrison. Okay. And again, the A 32 well is completing in 15 Q. 16 the Dakota, correct? 17 A. Correct. Did it ever produce from the Morrison? 18 Q. 19 No, it did not. Α. And then finally, although it's really not at 20 Q. issue today, the A 26 well, that is strictly a Paradox 21 22 well, correct? 23 Yes. Α. 24 And what is that well currently producing? Q.

It's currently producing at approximately a

million a day in gas.

- Q. What is Exhibit 3?
- A. Exhibit 3 is a cumulative production map with a nine-section area showing Section 2 in the center of it.
- Q. And is the bulk of the production from the Dakota and the Morrison and the Paradox in this area?
- A. Yes, the Morrison producers, this basically shows just Morrison and Dakota producers on this map, and the Morrison is the yellow, and then the Dakota is the other.
  - Q. Are there any oil wells in this area?
- A. There is one that has cum'd quite a bit of oil, but it's way -- it's in the southwest of Section 11.
- Q. Okay. The wells in the southeast quarter of Section 2, do they have any uphole zones of interest at this point?
  - A. Not at this point.
  - Q. What is Exhibit 4?
- A. Exhibit 4 is production plots for the Dakota wells that have produced in the southeast quarter of Section 2. The first one is the Ute Indians A 32.

It also has an estimate of the remaining reserves on that well for an estimated ultimate recovery, and the Ute Indians A 20 is the production plot for that well. and that well is currently P-and-A'd but shows the cumulative production prior to P-and-A'ing that well.

Q. Why don't you move on to Exhibit 5 and discuss the type of reserves you hope to recovery ultimately from both the wells, the 27 and the 32, if this Application is granted?

A. This exhibit shows the current producing Dakota wells. Of course the A 20 is P-and-A'd. The estimated ultimate recovery from the A 20 and A 32 is 523 million

The next table is recoverable gas in place, which was the same information we submitted in the previous hearing, and it shows that you're only going to recover approximately 37 percent of the recoverable gas in place for that guarter section.

And the last table is the estimation of remaining recoverable gas, which is basically recoverable gas minus the two producing wells, and that's around 900 million cubic foot in the guarter section.

- Q. Is the recompletion of the A 27 well necessary in order to adequately recovery Dakota reserves in this section?
  - A. Yes.

- Q. And were Exhibits 2, 3, 4 and 5 prepared by you or under your supervision --
  - A. Yes.
- Q. -- or compiled from company business records?

In your opinion, is the granting of this 1 Application in the interest of conservation and the 2 3 prevention of waste? Α. Yes. MR. BRUCE: Mr. Examiner, I'd move the admission 5 6 of Exhibits 2 through 5. EXAMINER STOGNER: Exhibits 2, 3, 4 and 5 will be 7 admitted into evidence at this time. 8 9 EXAMINATION 10 BY EXAMINER STOGNER: 11 Q. Mr. Voigt, I believe Mr. Bruce was asking the 12 previous examiner -- I'm sorry, the previous witness, about 13 the Number 27 and its plans on completion. It's a Morrison 14 at this point. Of course, it's being recompleted as a 15 Dakota. 16 Α. Yes. 17 Will the Morrison be plugged and abandoned? Q. 18 Α. It will be abandoned, and the Dakota will be 19 produced, and within a few years if we see that the 20 pressures have come down on the Dakota we'll consider 21 commingling the two zones. 22 Q. So essentially temporarily abandoned? 23 Yes, temporarily abandoned. Α. Now, when I refer to Exhibit Number 5 --24 Q. 25 Α. Yes.

-- the estimated remaining recoverable gas, is 1 Q. that with the Number 27 or just the Number 32 well? 2 That's just with the Number 32 well. 3 Α. And where will I find if the Number 27 -- what's 4 Q. 5 the estimated -- or do you have any numbers of potentially 6 unrecoverable reserves from the Number 27, if it was not 7 allowed to produce? If it was not allowed to produce, the estimated 8 Α. remaining recoverable gas, that last table --9 10 Q. Yes. -- is basically the recoverable gas minus what 11 the A 32 and the A 20, which is P-and-A'd, are going to 12 13 recover in that quarter section. So the remaining would be 900 million cubic that the A 27, if it weren't allowed to 14 15 produce, that would be the remaining gas --16 Q. Okay. -- in that quarter section. 17 18 Q. And just for the record, the Dakota gas is an 19 unprorated pool; is that correct? Not allocated, in other 20 words? There's no restriction on the production? No. 21 A. 22 Q. Okay. 23 MR. BRUCE: It is 160-acre spacing. 24 THE WITNESS: Yeah, it's 160-acre spacing 25 currently --

(By Examiner Stogner) And that leads to the 1 Q. necessity, because in an unprorated pool you can only have 2 3 one well. 4 Α. Yeah. Unprorated doesn't mean unrestricted, so that's 5 Q. how you -- how we simply regulate or establish the 6 7 conservation needs. When was that number 20 P-and-A'd? 8 9 Α. It was October of 2003. 10 Q. Any plans for any new wells in this area? 11 Not at that point. Α. Working with the holes you have, in other words? 12 Q. 13 Α. Correct. Okay. How about water production in any of these 14 Q. 15 What are you seeing as far as water? 16 Α. Small amounts, very little water. Maybe, you know, half a barrel a day. I know some of the lower Dakota 17 sandstones, i.e., the Burro Canyon sandstones that we do 18 have in this area, you do see some water production from 19 those, but the Dakota itself you don't see really too much 20 21 water production, unless you get into the lower sands. 22 Q. So the completion is naturally flowing though? 23 Α. Yes. No need of water or fluid pump-off? 24 Q.

EXAMINER STOGNER: Are there any other questions of this witness from anybody?

Thank you, Mr. Voigt, you may be excused.

Mr. Bruce, anything further?

MR. BRUCE: No, sir.

EXAMINER STOGNER: Again, I want to thank you for coming to this particular kind of a case. It's whereas I was leading up to the unprorated doesn't mean unrestricted, and anything that happens here, I've got to look at it through any kind of exception that is given at this point, what kind of precedent does that set elsewhere? And I've got to look at the rest of the whole state where we have a lot of fee acreage, state acreage, or the combination of the two.

So what may seem like a simple matter here where nobody's getting hurt could set precedents somewhere else, and that's what I have to contend with sometimes. So again, I do appreciate XTO's patience in this and the tribe's patience for this, but with these kind of cases and taken into consideration.

And also what happens here could be utilized if we ever want to infill drill some of the shallower gas in the San Juan Basin that's already spaced on 160. This could be taken into account of the necessity that exists here, and that would be applied throughout the San Juan

So bear that in mind if, in the future, infill Basin. drilling becomes necessary or we have a hearing for infill drilling for 160 in the northwest New Mexico. Again, thank you. And Case Number 13,327 will be taken under advisement.
