Dear Ms. Wrotenbery:

The Division has denied the motion of San Juan Coal Company ("SJCC") to continue the above case to December 6, 2001. It is now scheduled to be heard on October 18, 2001. The reason for this letter is twofold:

1. SJCC renews its motion to continue the case to December 6, 2001, and incorporates by reference the matters stated in its pleadings on file herein.
2. Pursuant to Division Rule 1211.B, SJCC requests a pre-hearing conference to discuss (a) the continuance motion, (b) SJCC's standing, and (c) the scope of the hearing. SJCC intends to present evidence at the hearing which Richardson claims is improper. 
