(NOTE: All land descriptions herein refer to the New Mexico Principal Meridian whether or not so stated.) **CASE 13340: Application of McEvelyn Oil & Gas Properties, Inc. for compulsory pooling, Rio Arriba County, New Mexico.** Applicant in the above-styled cause seeks an order pooling all uncommitted mineral interests in all formations from the surface to the base of the Mesaverde formation in the W/2 of Section 14, Township 25 North, Range 2 West, N.M.P.M. to form a standard 320-acre gas spacing and proration unit for all formations and/or pools developed on 320 acres within that vertical, which includes but is not necessarily limited to the Blanco-Mesaverde Gas Pool. Said unit is to be dedicated to applicant's proposed Badger Corn 14 Well No. 1 to be drilled at a standard gas well location 785 feet from the West line in Unit D of the NW/4 of said Section 14 to a depth sufficient to test any and all formations to the base of the Mesaverde formation. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof, as well as actual operating costs, and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well. Said area is located approximately 5 miles northeast of Lindreth, New Mexico.
