## STATEMENT OF THE CASE

APPLICANT
Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the following described acreage in Section 28, Township 22 South, Range 27 East, NMPM, and in the following manner: The S% to form a standard 320-acre gas spacing and proration unit for any and all formations and/or pools developed on 320-acre spacing; the SE% to form a standard 160-acre gas spacing and proration unit for any and all formations and/or pools developed on 160-acre spacing; and the SE%SE% to form a standard 40-acre gas spacing and proration unit for any and all formations and/or pools developed on 40-acre spacing. The units are to be dedicated to applicant's Skeen Well No. 2, to be located at an orthodox location in the SE%SE% of Section 28.
