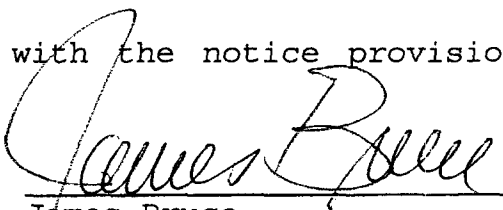

2. I am an attorney for COG Operating LLC.

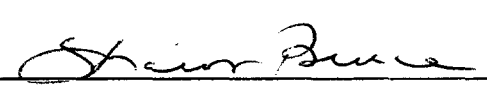
3. COG Operating LLC has conducted a good faith, diligent effort to find the names and correct addresses of the interest owners entitled to receive notice of the application filed herein.

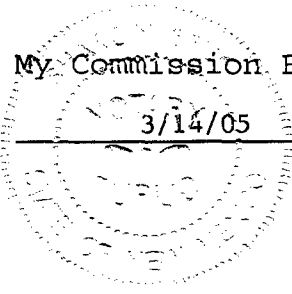

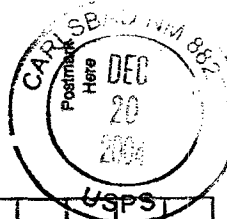
