1           WHEREUPON, the following proceedings were had at  
2 8:15 a.m.:

3           EXAMINER STOGNER: This hearing will come to  
4 order, Docket Number 03-05. Please note today's date is  
5 Thursday, January 20th, 2005.

6           I'm Michael Stogner, appointed Hearing Officer in  
7 today's cases.

8           It's going to be a short docket today.

9           Case Number 13,262, this is the Application of  
10 Energen Resources Corporation to amend the cost recovery  
11 provisions of Order Number R-1960, Rio Arriba County, New  
12 Mexico, this case is dismissed.

13           Case 13,375, Application of Paladin Energy  
14 Corporation for compulsory pooling, Lea County, New Mexico,  
15 this case is also dismissed.

16           Case Number 13,397, this is the Application of  
17 Yates Petroleum Corporation for approval of a unit  
18 agreement in Chaves County, New Mexico, this case will be  
19 continued to February 3rd.

20           Case 13,400, this is the Application of Platinum  
21 Exploration, Inc., to abolish the special rules and  
22 regulations for the South Knowles-Devonian Pool, Lea  
23 County, New Mexico, I understand this case was heard from  
24 January 6th, 2005, and was continued to today's docket.  
25 However, this case will be continued to February 17th.

1 Case 13,400 is continued to February 17th.

2 Case 13,401, Application of Platinum Exploration,  
3 Inc., to abolish the special rules and regulations for the  
4 Knowles-Devonian Pool, Lea County, New Mexico, I understand  
5 this case was also heard on January 6th, 2005, and was  
6 continued to today's docket. However, However, this case  
7 will be continued to February 17th. Again, 13,401 is  
8 continued to February 17th.

9 Case 13,125, now, this in the matter of Case  
10 13,125 being reopened pursuant to the provisions of  
11 Division Order Number R-12,069, which is an order that  
12 promulgated temporary special pool rules for the East Dean-  
13 Wolfcamp Pool in Lea County, New Mexico, this case will be  
14 continued to February 3rd.

15 And finally, Case 13,362, this shows up on the  
16 docket as an amended Application of the New Mexico Oil  
17 Conservation Division for a compliance order against KC  
18 Resources, Inc. I was notified that there has been an  
19 agreed compliance order -- and I believe that is designated  
20 Number 52 -- has been issued and agreed upon and signed by  
21 KC Resources and the Oil Conservation Division. Therefore,  
22 Case 13,362 is deemed unnecessary and is hereby dismissed.

23 Anything else that needs to come before Docket  
24 Number 03-05?

25 This hearing is adjourned.
