

Applicant seeks an order pooling all mineral interests from the base of the Queen formation to the base of the Bone Spring formation underlying the following described acreage in Section 29, Township 18 South, Range 30 East, NMPM, and in the following The N%SE% to form a standard 80-acre oil spacing and manner: proration unit for any and all formations and/or pools developed on 80-acre spacing within that vertical extent; and the NWXSEX to form a standard 40-acre oil spacing and proration unit for any and all formations and/or pools developed on 40-acre spacing within that vertical extent.
