1           WHEREUPON, the following proceedings were had at  
2 8:15 a.m.:

4           EXAMINER STOGNER: This hearing will come to  
5 order. Please make a note, today's date December 2nd,  
6 2004, Docket Number 33-04. I'm Michael Stogner, appointed  
7 Hearing Officer for today's cases.

8           We'll go through the continuances and dismissals  
9 first.

10           Let's go to the second page. Case Number 13,365,  
11 Nadel and Gussman Permian, L.L.C., for compulsory pooling,  
12 Eddy County, New Mexico. Case Number 13,365 will be  
13 continued to December 16th.

14           The next one, Case 13,389, Application of Nadel  
15 and Gussman Permian, L.L.C., for compulsory pooling, Chaves  
16 County, New Mexico. This case will also be continued to  
17 December 16th.

18           The next one down, Case 13,352, this is the  
19 Application of Samson Resources Company for compulsory  
20 pooling, Lea County, New Mexico. This case will also be  
21 continued until the 16th.

22           Let's go to page 3. On top of the page, Case  
23 13,390, Application of Pride Energy Company for an  
24 unorthodox location and for simultaneous dedication, Lea  
25 County, New Mexico. This case will be dismissed.

1           Next case, 13,379, and also the one after that,  
2   13,380, both of these cases are for Chi Energy, Inc., both  
3   of them are for compulsory pooling. 13,379 is in Eddy  
4   County, 13,380 is also in Eddy County. Both of these cases  
5   are also continued to December the 16th. Please make a  
6   note that these cases, I believe, were heard two weeks ago;  
7   is that correct, Mr. Bruce?

8           MR. BRUCE: That's correct, and there need to be  
9   some additional -- I had to get the advertisement in, and I  
10  still haven't gotten the --

11           EXAMINER STOGNER: All righty. Down at the  
12  bottom, 13,387, Latigo Petroleum, Inc., for a nonstandard  
13  gas spacing and proration unit and for an unorthodox gas  
14  well location in Lea County, New Mexico. I'm not sure  
15  which pool that's in, but this case is also continued to  
16  December the 16th.

17           Any other continuances or dismissals at this  
18  time?

19           There being none, just to let you know what will  
20  be happening today, I'll call the Yates case -- that will  
21  be the first one -- and then we will move to the second  
22  page down at the bottom and take 13,359 out of sequence,  
23  and then we will take the Bass and Devon Energy Production  
24  cases in the potash area, consolidate them or hear at one  
25  time, or we'll discuss that at that time.


